WHAT IS A FREEDOM PASS?

The freedom pass for older people gives free travel on most public transport in London 24 hours a day (9.30am on most National Rail services within the London area), and all day at weekends and on public holidays. This pass may also be used to travel on local bus services in the rest of England under the terms of the Concessionary Bus Travel Act 2007.

WHO IS ELIGIBLE?

Men and women aged 60 and over whose sole or principal residence is in a London Borough.

WHERE DO I APPLY?

YOU MUST APPLY IN PERSON.

If you live in one of the boroughs listed below you must apply at a Post Office® branch located in any of these boroughs:

Barnet, Bexley, Brent, Bromley, Camden, Croydon, Ealing, Enfield, Greenwich, Hackney, Hammersmith & Fulham, Haringey, Harrow, Hillingdon, Hounslow, Islington, Kensington & Chelsea, Kingston upon Thames, Lambeth, Lewisham, Merton, Newham, Redbridge, Richmond upon Thames, Southwark, Tower Hamlets, Waltham Forest, Westminster and City of London.

If you live in one of the boroughs listed below you must contact your local council for information about their issuing arrangements. Please note that Post Office® branches located in the boroughs below do not issue freedom passes.

Barking & Dagenham, Havering, Sutton and Wandsworth.

WHEN YOU APPLY

You must apply in person and bring this completed application form to the Post Office® unless you live in Barking and Dagenham, Havering, Sutton or Wandsworth, where you must follow the borough's instructions.

You must bring one item from each of the sections 1, 2 and 3 below.

If you are renewing your pass you MUST also bring your photocard and your current pass, as the pass will be revalidated and returned to you.

- If renewing your pass, your current freedom pass Photocard is sufficient
(if the photograph is still an accurate likeness)

- If this is your first application or your pass has been lost or stolen:
1 recent passport size photo of yourself

REPLACING LOST, STOLEN, FAULTY OR DAMAGED PASSES

Lost or stolen passes can be replaced at the place of issue*. You may be asked to attend an interview to explain the circumstances surrounding the loss. You must bring proofs as in sections 1, 2, and 3 above.

Faulty or damaged passes can be replaced at the place of issue*. You must bring proofs as in sections 1 and 2 above.

You are not allowed to hold more than one concessionary pass at any one time. Only use the most recently obtained pass and return any others.

If you find a pass you have previously lost it will no longer work, please send it to the following address: FREEPOST FREEDOM PASS RETURNS. (Please note: This is all you need to write on the envelope. No stamp required)

NATIONAL SCHEME

From 1 April 2008, all freedom passes issued to older London residents can be used on local bus services anywhere in England as set out in the Concessionary Bus Travel Act 2007.

Outside of London, these pass holders will be able to travel free between 9.30am and 11.00pm Monday to Friday and all day at weekends and on public holidays. You will need to show your freedom pass and photocard to the bus driver.

A freedom pass will only be valid outside London if it has been renewed and re-stickered with a 2010 expiry date, a red rose logo and a bus hologram.

The pass will not be valid on trams, light railway, metro or train services outside of London.
