- A. THE HOUNSLOW (EAST CHISWICK) (PARKING PLACES) (2009, NO. 3)
(AMENDMENT NO. **) ORDER 20****
1. The Council of the London Borough of Hounslow propose to make the above-mentioned Order under sections 45 and 124 of the Road Traffic Regulation Act 1984.
 2. It is necessary to amend the description in the above parking places Order to facilitate a vehicle crossover to No. 43 Homefield Road, Chiswick.
 3. The Council of the London Borough of Hounslow, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49, 51 and 124 of the Road Traffic Regulation Act 1984^a as amended, and of all other powers thereunto enabling hereby make the following Order:

1. This Order may be cited as the London Borough of Hounslow (East Chiswick) (Parking Places) (2009, No. 3) (Amendment No. **) Order 20** and shall come into operation for all purposes on ** ***** 20**.
2. In this Order,

“the Order of 2009” means the London Borough of Hounslow (East Chiswick) (Parking Places) (No. 3) Order 2009^b; and

the expression “enactment” means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred by the coming into operation of this Order, the Order of 2009 shall have affect as though:
 - (a) the item in Schedule 7 to that Order numbered 100 was revoked; and
 - (b) the items were added to Schedule 7 to that Order numbered 100a and 100b as set out in Schedule to this Order.

SCHEDULE

In relation to a parking place referred to in this Schedule, the expression "permitted hours" means the period between 9am and 7pm on Mondays to Saturdays inclusive, any such day not being Christmas Day, Good Friday or a Bank Holiday.

Parking places in respect of which a vehicle may be left during the permitted hours if it displays a valid residents' parking permit or a valid resident's visitor parking card.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

The Hounslow (East Chiswick) (Parking Places) (No. 3) Order 2009 designated parking places in streets in the vicinity of East Chiswick Area in the London Borough of Hounslow at which charges may be made by the Council of the Borough for vehicles authorised by that Order to be left in those parking places during the permitted hours.

This Order amends the Order of 2009 by the substitution of residents' parking places in Homefield Road, Chiswick to match what is currently on street as well for the provision of vehicle crossover to No. 43 Homefield Road, Chiswick.

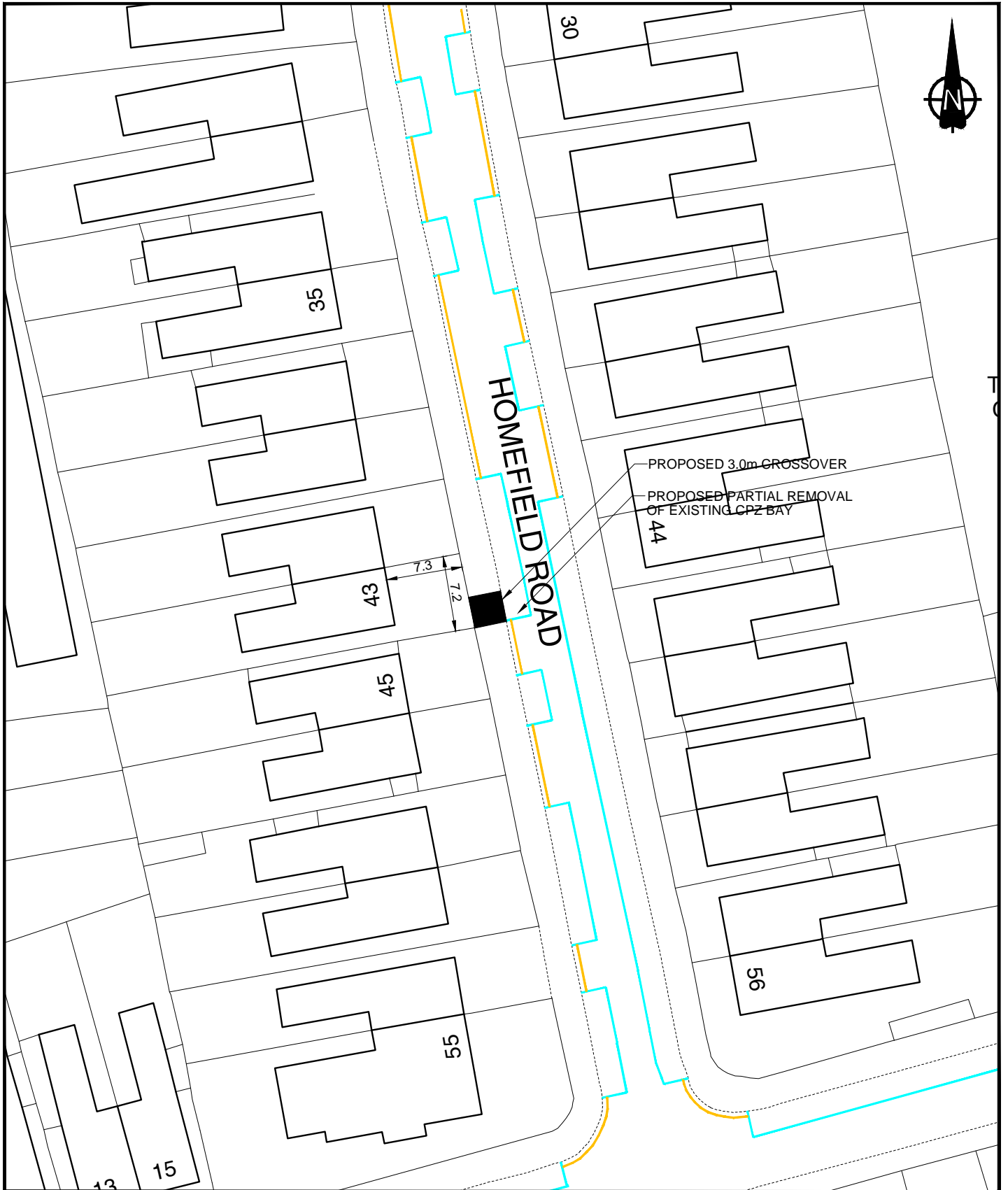
