### **Twickenham Event - Parking Consultation**

The Twickenham Event controlled parking zone (CPZ) was introduced in 1999. The CPZ operates solely when there is a major event at Twickenham Rugby Stadium so as to provide parking priority for residents and businesses in a number of roads surrounding the stadium. Roads or parts of roads situated inside the CPZ fall under either the London Borough of Richmond or the London Borough of Hounslow.

Both councils have had complaints concerning parking problems on event days in the areas immediately outside the existing CPZ. The purpose of this joint consultation is to seek the views of residents and businesses situated in roads within the blue and green boundaries shown on the attached plan on whether they would like the existing Event CPZ (zone R) extended.

Please complete the questionnaire and return it by **Monday 6 July 2009**. It is important for us to know your views in order to make an informed decision.

Further information on this consultation and on how the CPZ works can be obtained from the contact details below. Essentially, the CPZ will be a permit based scheme, with permits issued only to residents and businesses within the CPZ. Currently, there is no charge for permits and each household/business will be issued one resident permit per resident and two visitor permits per household.


