## **Commentary:**

In the financial year 2016/17 the council secured over £21.8 million where the top three categories in terms of the size of contributions agreed were Affordable Housing, Construction/Employment Training and Highways/Traffic and Parking;

Total financial contributions received in this financial year through S106 monies amounted to around £11.7 million;

Benefits delivered through s106 contributions based on spend in 2016/17 was just over  $\pounds$ 4 million.
