## STOPPING UP OF HIGHWAYS SECTIONS 247 and 252 TOWN AND COUNTRY PLANNING ACT 1990 Land to rear of Cavendish Parade, Bath Road, Hounslow West TW4 7DJ

THIS ORDER is made by the London Borough of Hounslow ("the Council"), acting in its capacity as a local highway authority, in exercise of its powers under Section 247 and 252 of the Town and Country Planning Act 1990 ("the Act") as amended by the Greater London Authority Act 1999 and any other enabling powers.

## BY THIS ORDER

- 1. The Council authorises the stopping up of an area of the highway at land known as Land to rear of Cavendish Parade, Bath Road, Hounslow West TW4 7DJ and specifically the carriageway on Earl Haig Close with an area of 56.3m2 (14.0 x 8.1m irregular shape), the carriageway on Siddeley Drive with an area of 24.5m<sup>2</sup> (4.0 x 6.1m) and the footway on Siddeley Drive adjacent to the carriageway with an area of 3.7m<sup>2</sup> (4.0 x 0.9m) shown in red on the Plan annexed as the Council is satisfied that this will be necessary in order to enable the development described in the Schedule to this Order to be carried out in accordance with the planning permission granted by the Council pursuant to planning application number 00083/Q8/P13.
- 2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of highway authorised to be stopped up pursuant to this Order, then subject to Section 261(4) of the Act, those undertakers shall have the same rights in relation to that apparatus after the making of this Order as they had before.
- 3. This Order shall come into force on the date on which notice that it has been made is first published in accordance with section 252(10) of the Act and may be cited as the Stopping up of highways at Land to rear of Cavendish Parade, Bath Road, Hounslow West TW4 7DJ 2019.
