- 1. The London Borough of Hounslow hereby gives Notice that on 12 August 2020 it made the above Order under the Road Traffic Regulation Act 1984.
- 2. The general effect of the Order, which will come into operation on 17 August 2020, will be to continue indefinitely:
 - waiting restrictions in Access road leading to the rear of Nos. 1 to 11 Badger Close, Badger Close, Chinchilla Drive, Ermine Close, Marmot Road, Mink Court, Musquash Way, Opossum Way, Raccoon Way, Sable Close and Squirrel Close operational between Monday to Friday 8am-5pm;
 - b. waiting restrictions in The Croft operational Friday 7am-noon;
 - c. waiting restrictions in Marlborough Road operational Wednesday 9am-11am; and
 - d. "no waiting at any time" restrictions in Chinchilla Drive, Hounslow and The Croft, Hounslow
- 3. Documents giving detailed information of the Order can be viewed for a period of 6 weeks from the date of this Notice online at <u>hounslow.gov.uk</u> by typing in the term "traffic notices" in the search bar.
- 4. Any person desiring to question the validity of the Order or any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant regulations made thereunder have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make an application for the purpose to the High Court.

Made on 10 August 2020 Coming into operation on 17 August 2020

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 to the Road Traffic Regulation Act 1984¹ as amended, and of all other enabling powers hereby make the following Order:

- 1 This Order shall come into operation on 17 August 2020 and may be cited as the London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No. 268) Order 2020.
- 2 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hounslow (Waiting and Loading Restriction) Order 2008² shall have effect as though:
 - (a) the items numbered 355, 548, 941, 942, 943, 944, 945, 946, 947, 948, 949, 950 and 1133 in Schedule 1 to that Order were substituted with the items similarly numbered and set out in Schedule 1 to this Order.




(This Note is not part of the Order, but is intended to indicate its general purport.)








- 2. The general effect of the Order, which comes into effect on 18 February 2019, will be to introduce:
 - a. Monday to Friday 8am-5pm, waiting restrictions in Access road leading to the rear of Nos. 1 to 11 Badger Close, Badger Close, Chinchilla Drive, Ermine Close, Marmot Road, Mink Court, Musquash Way, Opossum Way, Raccoon Way, Sable Close and Squirrel Close, Hounslow;

In pursuance of Section 10(2) of the Road Traffic Regulation Act 1984, the Director of Regeneration, Economic Development & Environment, or a person authorised by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs, modify or suspend the Order or any provision thereof.

The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No. 9) Order 2009

Made on 22 June 2009 Coming into operation on 29 June 2009

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹, as amended by sections 8 and Schedule 5 of the Local Government Act 1985² and the Traffic Management Act 2004³ and of all other powers thereunto enabling hereby make the following Order:

- 1 This Order shall come into operation on 29 June 2009 and may be cited as the London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No. 9) Order 2009.
- 2 In this Order, the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of any enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- Without prejudice to the validity of anything done or to any liability incurred by the coming into operation of this Order, The Hounslow (Waiting and Loading Restriction) Order 2008⁴ shall have effect as though
 - (a) items in Schedule 1 and 2 were replaced by items in Schedule 1 and 2 as set out in columns 1, 2 and 3 to this Order.
