- 1. The London Borough of Hounslow hereby gives Notice that on 19 October 2020, the Assistant Director Transport, Parking & Environmental Strategy in exercise of the powers conferred by Section 10(2) of the Road Traffic Regulation Act 1984, as amended, modified the above Order.
- 2. This modification is required to change the specified times that prohibited motor vehicles, except permit holders, can enter those streets detailed in Schedule to this Notice.
- 3. This modification will come into effect on 2 November 2020.

The London Borough of Hounslow (No.29) Experimental Order Modification (No.1) Order 2020

Made on 19 October 2020 Coming into operation on 2 November 2020

The Assistant Director Transport, Parking and Environmental Strategy, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers provided by Section 10(2) of the Road Traffic Regulation Act 1984^a, as amended, and in the interests of the expeditious, convenient and safe movement of traffic, hereby makes modifications to the London Borough of Hounslow (No.32) Experimental Order 2020^b (hereinafter known as "the experimental Order"):

- 1. This modification Order shall come into operation on 2 November 2020 and may be cited as the London Borough of Hounslow (No.29) Experimental Order Modification (No.1) Order 2020.
- 2. The experimental Order shall be modified such that no person shall cause any motor vehicle to enter the street specified in column 2 of Schedule 1 during the prohibited hours unless otherwise stated in column 3 of the said Schedule.
- 3. The Council of the London Borough of Hounslow, when making the experimental Order, gave notice on 1 September 2020 that if the provisions of the experimental Order continued in operation for a period of not less than six months, the Council will consider in due course whether they should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. The date by which a person wishing to object to or support the making of such an Order for the purpose of such reproduction and continuation in force is hereby varied to 19 April 2021.

Hounslow Town Centre School Street – Restricted Access Restrictions – Notice of Modification

Statement of Reasons

The Council on 17 August 2020 introduced an experimental order to restrict motor vehicles accessing School Road and Pears Road within the borough as part of its School Streets programme.

This Modification order will change the specified times that prohibited motor vehicles, except permit holders, can enter the above roads to 8.30am to 9.30am and 2.45pm to 3.45pm.

These measures are initially being introduced on an experimental basis for a period between 6-18 months to allow the assessment of any impact the access restrictions might have on the area and surrounding roads, and to revise the scheme if necessary within that time. A review will be carried out to assess their effectiveness and whether the timed access restrictions should be made permanent.
