A. The London Borough of Hounslow (Chiswick Riverside) (Parking Places) (Amendment No.1) Order 2020

1. The London Borough of Hounslow on 2 November 2020 made above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on 5 November 2020.
2. The general effect of the Order will be to allow residents of Flats 1-31, 2 Kew Bridge Road, Brentford, to be eligible for resident permits in the Chiswick Riverside CPZ. Permits will be limited to one permit per property.

4. STATEMENT OF REASONS

Inclusion of Flats 1-31, 2 Kew Bridge Road, Brentford in Chiswick Riverside CPZ (Strand-on-the-Green area)

Following the introduction of the Chiswick Riverside CPZ (also referred to as the Strand-on-the-Green Area) in December 2017 and the undertaking of an experimental order, the Council has agreed to make residents of flats 1-31, 2 Kew Bridge Road, Brentford eligible for resident permits.

Occupants of Flats 1-31, 2 Kew Bridge Road, Brentford will be limited to purchase no more than 1 permit per property.
