

# **Project details**

## **Executive summary**

The London Borough of Hounslow is currently responsible for 29 active allotments sites. The Borough is committed to working with allotment holders and partners to support and plan for allotments, and to strengthen their role in maintaining and enhancing them, ensuring they will be there for future generations to enjoy. To deliver this vision, the Borough has drafted a new Allotment Strategy for Hounslow, providing guidance for the next five years.

LB Hounslow commissioned M·E·L Research to independently carry out the consultation, gathering views from the public and other stakeholders. To do this, we ran an online survey for five weeks from  $19^{th}$  May to  $23^{rd}$  June 2020.

We heard from exactly 200 residents, of which the vast majority were Hounslow residents that currently rent an allotment plot in the Borough. We also heard from representatives of allotment societies, groups and associations, as well as employees of community or voluntary sector organisations and schools.

### **Key findings:**

- The vast majority (91%) agreed with the Borough's vision, as set out in the strategy, to "maximise their value for health and wellbeing, stronger communities, biodiversity and sustainable living."
- 84% of respondents agreed with the strategy's commitment to improving infrastructure to enhance customer experience.
  - When asked why, respondents mentioned that facilities such as better security, toilets and water provision were needed (or needed improving).
- 69% of respondents agreed with the commitment to strengthening partnerships to maximise use and health and wellbeing opportunities.
  - However, comments left by respondents suggest that they believe this should be allocated fairly so that those on waiting lists can still get access to plots, as opposed to plots being prioritised for community or school initiatives.
- 84% of respondents agreed with the strategy's commitment to improving management practices to increase service standards.
  - The key theme from comments was that uncultivated plots were an issue for current tenants who would like to see these plots reallocated.
- 76% of respondents agreed that a key commitment should be to identify interventions to improve sustainability.




- Respondent comments suggest they felt this commitment should be encouraged rather than forced. A large proportion of respondents also said that a waste and recycling collection was needed to improve sustainability.
- When asked if they felt anything was missing from the vision or key commitments outlined in the strategy, commonly mentioned themes included the need for more resources and capacity (including better management and communication) and the need for rules to be enforced. Improvements to infrastructure and more opportunities for education and engagement were also suggested, although these are already in the strategy.

## Introduction

### **Background**

Allotments have made a revival over recent years because of their vital role in connecting people to the process of food production, promoting health and wellbeing through exercise and healthy eating and bringing the community together to share advice, experience and a passion for growing food and other plants.

The London Borough of Hounslow is currently responsible for 29 active allotment sites (as shown below). The Borough shares the above vision for allotments and is committed to working with allotment holders and partners to support and plan for allotments, and to strengthen their role in maintaining and enhancing them, ensuring allotments will be there for future generations to enjoy.



This builds on wider Borough strategies, particularly the new corporate plan of making Hounslow cleaner and greener. Hounslow is one of a growing list of public bodies to have declared a climate emergency, which is feeding into all Borough plans. On top of that, it is estimated that over half of adults in Hounslow are overweight<sup>1</sup>, stressing the need to eat healthily and keep fit.

To deliver this vision, the Borough has drafted a new Allotment Strategy for Hounslow. This forward-looking strategy will provide guidance for the next five years on the management, development and maintenance of current allotment provision.

The strategy sets out the wider context and background to allotments, both within Hounslow and nationally, and includes a vision for allotments in Hounslow and an action plan based around four key themes:

- Improving infrastructure to enhance customer experience
- Strengthening partnerships to maximise use and health and wellbeing opportunities
- Improving management practices to increase service standards
- Identifying interventions to improve sustainability

### **Consultation process**

Before consulting on the draft strategy, M·E·L Research were commissioned to assist the Borough with a resident engagement process. This included an online and face-to-face survey with allotment holders in the Borough, to understand more about their needs and priorities. Alongside this, we carried out a focus group and three 'chattabouts' with non-users of allotments to understand their perceptions and any barriers to use. Finally, in October 2019 the Borough ran an allotment seminar to further inform the drafting of the new Allotment Strategy.

Following this extensive resident engagement process and the drafting of the strategy, M·E·L Research were commissioned to independently carry out the consultation, gathering views from the public and other stakeholders. To do this, we ran an online survey for five weeks from 19<sup>th</sup> May to 23<sup>rd</sup> June 2020. During this period Covid-19 has been the national context, so it's possible that this may have affected people's responses, as we have heard from them during the national lockdown phase.

There was wide communication about the consultation. LB Hounslow publicised the consultation in several ways, with posters put up at allotments and parks' noticeboards, via social media and by directly contacting a range of stakeholders.

A copy of the survey is included in Appendix A.

## **Results**

### **Respondent profile**

Overall, 200 residents took part in the consultation. The vast majority were residents who currently rent an allotment plot in the Borough. We also heard from representatives of allotment societies, groups and associations, as well as employees of community or voluntary sector organisations and schools. A full respondent profile is included in Appendix B.




Figure 2: Gender





Figure 3: Age

Respondents who currently rent an allotment plot within the Borough were asked which site their plot is located in. Table 1 below shows the number and percentage of these responses by site. This shows that there was some representation from almost all allotment sites.

### **Overall vision**

All respondents were asked to what extent they agree or disagree with the overall vision set out in the Allotment Strategy.

Our overall vision for allotments in Hounslow is to "maximise their value for health and wellbeing, stronger communities, biodiversity and sustainable living."

The vast majority (91%) agreed with the overall vision, with six in ten (62%) agreeing strongly. Just 2% of respondents disagreed and 7% had no strong feelings either way.

Respondents were then asked to explain why they agree/disagree with the overall vision. 114 respondents left a valid comment. These have been coded into themes and the results are presented below.

The vast majority stated that they agree with the sentiment of the vision, that allotments are good for health and wellbeing and provide opportunities for socialising and learning (62% of comments). A further 15 comments expressed general agreement with the vision and 13 comments suggested that more allotments, opportunities to get involved or a fairer allocation policy was needed.

### **Priorities**

To help move the strategy forward, the Borough has outlined four key commitments. These are:

- Improving infrastructure to enhance customer experience
- Strengthening partnerships to maximise use and health and wellbeing opportunities
- Improving management practices to increase our service standards
- Identify interventions to improve sustainability

All respondents were asked to what extent they agree or disagree that each of these areas should be a key commitment.


### Improving infrastructure to enhance customer experience

(e.g. reviewing toilet provision, identifying accessibility and security issues, improving site signs and introducing water butts)



The vast majority (84%) agreed with this commitment, with almost six in ten (58%) agreeing strongly. 7% of respondents disagreed and one in ten (10%) neither agreed nor disagreed.

Respondents were then asked to explain why they agree/disagree. 131 respondents left a valid comment. These have been coded into themes and the results are presented below.

The top themes included the need for better security (40% of comments), the need for on-site toilets (34% of comments) and better water provision including more water taps, the provision of water butts and the ability to use a hose (31% of comments).

# Strengthening partnerships to maximise use and health and wellbeing opportunities




(e.g. working with community groups, schools and GPs to increase allotment capacity and use)

Almost seven in ten (69%) respondents agreed that strengthening partnerships to maximise the use of allotments and health and wellbeing opportunities should be a key commitment in the strategy. A greater proportion (38%) agreed than strongly agreed (31%). Just 7% disagreed, while almost a quarter (24%) had no strong feelings either way.

Respondents were then asked to explain why they agree/disagree. 110 respondents left a valid comment. These have been coded into themes and the results are presented below.

Over a quarter of comments (26%) suggested a need for fair allocation and management (to ensure those on the waiting list still get access to plots rather than being given to community groups/schools), whilst a fifth (21%) of comments agreed with the commitment to strengthening partnerships with



schools and the wider community. 12 comments also gave examples of this already happening on their site whilst a similar proportion felt this wasn't a high priority or had reservations.

# Improving management practices to increase our service standards



(e.g. reviewing non-cultivation, reviewing management of waiting lists, establishing an Allotments Forum and exploring self-management)

The vast majority (84%) agreed with the commitment to improve management practices to increase service standards, with more than half (53%) agreeing strongly. Just 4% of respondents disagreed and 13% neither agreed nor disagreed.

Respondents were then asked to explain why they agree/disagree. 125 respondents left a valid comment. These have been coded into themes and the results are presented below.

The most popular theme, mentioned in 45% of comments, was issues with uncultivated plots. Respondents mentioned this was an issue on their site or suggested these plots should be reallocated and tenants removed. Other common themes included the want for tenancy agreements to be enforced or more regular inspections (20% of comments) and issues with waiting lists such as lists being too long and residents queue-jumping (18% of comments).

### Identifying interventions to improve sustainability

(e.g. reviewing waste management systems, encouraging organic practices and making peat free products compulsory)



Over three quarters (76%) of respondents agreed that a key commitment of the strategy should be to identify interventions to improve sustainability, with a greater proportion agreeing strongly (41% compared to 35%). Just 7% disagreed and one in six (17%) had no strong feelings either way.

Respondents were then asked to explain why they agree/disagree. 112 respondents left a valid comment. These have been coded into themes and the results are presented below.

The most common themes included the need for better waste management (31% of comments), general agreement with the commitment to improve sustainability (25% of comments) and suggestions for more education and encouragement on best practice sustainability or the inclusion of



the need to be sustainable within tenancy agreements (22% of comments). However, a proportion of respondents felt that this should not be a compulsory or enforced measure.

### **Our strategy - further suggestions**

Respondents were asked if they felt there was anything missing from the vision and the key commitments outlined in the strategy. A total of 109 valid comments were made on additional areas respondents felt should be included. These have been coded into themes and the results, together with a selection of comments are presented below.

The most common themes included the need for more resources and capacity (including better management and communication) in order to implement the strategy (21%) and the need for rules to be enforced, evicting problem tenants if necessary (16%). Other themes reiterated points outlined in the strategy such as infrastructure improvements and more opportunities for education and engagement.

#### More resources and capacity/ better management/ better communication

- "It should be focused on identifying demand for allotments and providing allotments."
- "More hands-on management is required to ensure that the good running and maintenance of sites is properly addressed. There are too many unused plots and security on sites is severely compromised by damaged fencing the has not been repaired for several years. To overcome these problems, I think that rents should be increased gradually and realistically as long as they are ring fenced for allotment purposes only."

### Enforce rules/ tenancy agreements and evict problem tenants/ more rules (e.g. on sheds)

- "Enforced evictions of tenants who are not using the allotments as intended needs to take place, in order to maximize the number of people who can benefit from the very limited resource."
- "The enforcement of rules and regulations is difficult, but it should be that any clear infraction of these can be reported with the clear knowledge that action will be taken. This is not the case at the moment."

#### Infrastructure (waste management/ supply of compost, manure etc./ water supply)

- "Helping with waste removal would really help to stop fly tipping and reduce car use."
- "Water management. Introducing metered water facilities."

#### **Education and engagement (Forums, Champions, social events etc.)**

- "Would be very useful for them to help organise buy/sell/exchange events for the allotment holders e.g. horse manure from stables allotment holders would be happy to pay for this; stable holders could use the extra cash. School children could grow seedlings/plants in schools and sell to allotment holders nice interactions + funds raised for schools. If there are gardening experts at the council level that could advise allotment holders from time to time that would be invaluable."
- "Encourage social events. Religious festivals, open days, harvest, annual barbeque etc. Educational lectures."



### **Further comments and improvements**

#### **Further actions**

Section 9 of the Allotment Strategy sets out the Action Plan 2020 - 2025, which includes the main aims for improving the allotment service in the Borough. Respondents were asked if there were any specific actions they felt were missing that would improve the service, including making allotments more accessible. A total of 73 respondents left a valid comment. These have been coded into themes and the results, together with a selection of comments are presented below.

Again, common themes included the need for improvements to site infrastructure, including the security and safety of sites and more resources and capacity from the allotment service to enforce the plans set out in the strategy.

"Better path maintenance. So elderly people can access their plots easily. More security, stop people from outside dumping stuff in the allotment."

"I feel very strongly about correct waste management, sustainability (e.g. encouraging plot holders to recycle and upcycle whenever possible)."



"Ensuring sites are safe properly protected and have good basic facilities is a great thing. A clear point of management that is not heavy handed but able to act when needed."

"Providing a constant robust administration service is essential to ensuring that allotment sites are well managed."

### **Additional comments**

Finally, respondents were asked if they had any additional comments on the Allotment Strategy. 53 respondents left a valid comment. These have been coded into themes and the results, together with a selection of comments are presented below.
