NOTICE is hereby given that the London Borough of Hounslow (“the Council”) acting in its capacity as a local highway authority, has made an Order under section 247 of the above Act (as amended) entitled the Land fronting 237-239 High Street, Hounslow, TW3 1EA Stopping Up Order 2021 in the London Borough of Hounslow comprising the footway fronting 237-239 High Street with an area of 8.9m² and measuring 1.3m x 6.85m shown hatched black and edged in blue on the plan attached to the Order.

Any person aggrieved by the making of the Order and desiring to question the validity of the Order (or of any provision contained therein) on the ground that the Order is not within the powers of the above Act or that any requirement of that Act or of any regulation made under the Act has not been complied with in relation to the Order, may, within 6 weeks of the date of this notice, apply to the High Court for suspension or quashing of the Order or of any provisions contained therein.

THIS ORDER is made by the London Borough of Hounslow ("the Council"), acting in its capacity as a local highway authority, in exercise of its powers under Section 247 of the Town and Country Planning Act 1990 ("the Act") as amended and any other enabling powers

BY THIS ORDER

1. The Council authorises the stopping up of highway at the land fronting 237-239 High Street, Hounslow, TW3 1EA and specifically the footway with an area of 8.9m² and measuring 1.3m x 6.85m shown hatched black and edged blue on the annexed plan as the Council is satisfied that this is necessary in order to enable the development described in the Schedule to this Order to be carried out in accordance with the planning permission granted under Part III of the Act by the Council on 4 August 2020 under planning reference number 00610/237-239/P17.
2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of highway authorised to be stopped up pursuant to this Order, then subject to Section 261(4) of the Act, those undertakers shall have the same rights in relation to that apparatus after the making of this Order as they had before.
3. This Order shall come into force on the date on which notice that it has been made is first published in accordance with section 252(10) of the Act and may be cited as the Land fronting 237-239 High Street, Hounslow, TW3 1EA Stopping Up Order 2021
