Amendment to Bus Lane Operational Hours

A. The London Borough of Hounslow (Bus Lanes) Order 2021

- The London Borough of Hounslow hereby gives Notice that on 1 November 2021 it made the above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on 4 November 2021
- 2. The general effect of the Order will be to make permanent the experimental amendment of the hours of operation for bus lanes within the London Borough of Hounslow to either 24-hours or 7am to 7pm as indicated by traffic signs.
- Documents giving further information of the Order can be viewed for a period of 6 weeks
 from the date of this Notice online at hounslow.gov.uk by typing in the term "traffic notices"
 in the search bar.
- 4. Any person desiring to question the validity of the Order or any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant regulations made thereunder have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make an application for the purpose to the High Court.

Made on 1 November 2021 Coming into operation on 4 November 2021

The London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984^a, as amended, and of all other enabling powers hereby makes the following Order:

1. Commencement and Citation

- (1) This Order shall come into operation on 4 November 2021 and may be cited as the London Borough of Hounslow (Bus Lanes) Order 2021
- (2) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this order, the following orders are hereby revoked:

2. Interpretation

(3) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"Council" means the Council of the London Borough of Hounslow;

"bus", "bus lane", "local bus" "pedal cycle" and "taxi" have the same meanings as in the Traffic Signs Regulations and General Directions 2016^k;

"dial-a-ride bus" means a vehicle in the service of Transport for London providing transport for persons with permanent or long-term disability.

3. Prohibition

- (1) No person shall cause any vehicle:
 - to be in a bus lane placed on the length of road specified in column 2 of Schedule 1 during the times specified in column 3, unless otherwise stated in column 5 of the said Schedule: or
 - b) to proceed in a bus lane placed on the length of road specified in column 2 of Schedule 1 in a direction other than that specified in column 4 of the said Schedule.

4. Exemptions

(1) Nothing in this Order shall apply to:

- a) a vehicle being in a bus lane for as long as may be reasonably necessary to enable a person to board or alight from the vehicle and to load or unload their personal luggage so far as the activity is not prohibited by the provisions of any other Order;
- b) a vehicle being in a bus lane for as long as may be reasonably necessary for the purpose of delivering or collecting goods from premises adjacent to the length of road on which the bus lane is placed so far as the activity is not prohibited by the provisions of any other Order.
- c) a vehicle crossing the bus lane so as to enter or leave designated parking or loading places adjacent to the length of road on which the bus lane is placed;
- d) a vehicle crossing the bus lane so as to enter or leave an adjoining road, land or premises adjacent to the length of road on which the bus lane is placed;
- e) a vehicle entering the bus lane due to circumstances outside the control of the driver or so as to avoid an accident;
- f) a vehicle entering the bus lane for the purpose of complying with any direction of a constable in uniform or a traffic warden;
- g) the vehicle is being used for at least one of the following purposes:
 - i) fire and rescue authority;
 - ii) ambulance;
 - iii) blood service;
 - iv) providing a response to an emergency at the request of an NHS ambulance service;
 - v) bomb or explosive disposal;
 - vi) special forces;
 - vii) police; or
 - viii) National Crime Agency.
- h) a vehicle proceeding in accordance with any restriction or requirement indicated by traffic signs placed pursuant to sections 66, 67 and 68 of the Road Traffic Regulation Act 1984:
- a vehicle being used in the service of the Council or Transport for London in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to enter the bus lane;
- j) a vehicle being used for the purpose of laying, erection, alteration or repair of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system in or adjacent to the bus lane provided that in all the circumstances it is reasonably necessary for that vehicle to enter the bus lane for the purpose of undertaking such work; and
- k) a vehicle being used for the purpose of any maintenance, improvement or construction of bus stop infrastructure adjacent to the length of road on which the bus lane is placed.
- (2) Any person duly authorised by the Council may suspend a bus lane or any part thereof whenever they consider such suspension reasonably necessary:
 - a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - b) for the purpose of:
 - i) any building operation, demolition or excavation;
 - ii) the maintenance, improvement or reconstruction of the highway; or
 - iii) the laying, erection, alteration or repair of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunication systems in or adjacent to the bus lane; or
 - c) on any occasion on which it is likely by reason of some special attraction that the street will be thronged or obstructed.

Experimental Amendment to Bus Lane Operational Hours

A. The London Borough of Hounslow (No.3) Experimental Order 2020

- 1. The London Borough of Hounslow hereby gives Notice that on 8 June 2020 it made the above Order under Section 9 of the Road Traffic Regulation Act 1984.
- 2. The general effect of the Order, which comes into effect on 18 June 2020, will be to amend the hours of operation for bus lanes within the London Borough of Hounslow to either 24-hours or 7am to 7pm as indicated by traffic signs. Loading to premises adjacent to a bus lane will be retained.
- 3. Documents giving further information of the Order can be viewed online at hounslow.gov.uk by typing in the term "traffic notices" in the search bar. Documents will be available for viewing until the end of eighteen months from the date on which this Notice is published.
- 4. The Order provides for the Assistant Director for Transport, Parking and Environmental Strategy, or any person authorised by him to modify or suspend the Order or any provision of it, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs.
- 5. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.
- 6. If the provisions of the Order continue in operation for a period of at least six months, the Council will consider in due course whether the provisions of the experimental Order should be continued in force indefinitely by means of a permanent Order. Any person desiring to object to the making of an Order for the purpose of such indefinite continuation may, within six months of the experimental Order coming into operation, send a statement in writing of the objection and the grounds on which it is made to the Assistant Director for Transport, Parking and Environmental Strategy, Hounslow House, 7 Bath Road, Hounslow TW3 3EB or by email to trafficorders@hounslow.gov.uk quoting the reference TMO/E003/20.

- a vehicle being used in the service of the Council or Transport for London in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to enter the bus lane;
- j) a vehicle being used for the purpose of laying, erection, alteration or repair of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system in or adjacent to the bus lane provided that in all the circumstances it is reasonably necessary for that vehicle to enter the bus lane for the purpose of undertaking such work; and
- k) a vehicle being used for the purpose of any maintenance, improvement or construction of bus stop infrastructure adjacent to the length of road on which the bus lane is placed.
- 6. In pursuance of Section 10(2) of the Road Traffic Regulation Act 1984, the Assistant Director for Transport, Parking & Environmental Strategy, or any person authorised by him, may modify or suspend the Order or any provision of it, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs.

Experimental Amendment to Bus Lane Operational Hours

Statement of Reasons

The London Borough of Hounslow has made the decision to implement an experimental traffic order to amend the bus lane hours across the borough.

This change in hours will help ensure more space for those people, including keyworkers, who are using the borough's main roads on bicycles to access jobs and services. It will also assist in providing additional space for those looking to get exercise through cycling.

Loading to premises adjacent to a bus lane will be retained.

The change to the bus lane operational hours will be in place for a minimum of 6 months, after which the hours will be reviewed to determine if they should be made permanent.
