Burlington Lane, Chiswick – Proposed extension of Chiswick Mall Controlled Parking Zone

A. The London Borough of Hounslow (Chiswick Mall) (Parking Places) (No.9) (Amendment No. xx) Order 20**

1. The Council of the London Borough of Hounslow proposes to make the above Order under sections 6 and 124 of the Road Traffic Regulation Act 1984.
2. The general effect of the Order would be to continue in force the extension of the Chiswick Mall controlled parking zone to include the lay-by fronting Nos.30-80 Burlington Lane, Chiswick, as currently indicated by traffic signs.
3. Documents giving further information of the proposed Orders can be viewed for a period of 21 days from the date of this Notice online at hounslow.gov.uk by typing in the term “traffic notices” in the search bar.
4. The London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984^a, as amended, and of all other enabling powers hereby make the following Order:

1. This Order shall come into operation on DATE 20** and may be cited as the London Borough of Hounslow (Chiswick Mall) (Parking Places) (No.9) (Amendment No. 3) Order 20**
2. In this Order, “the Order of 2009” means the London Borough of Hounslow (Chiswick Mall) (Parking Places) (No.9) Traffic Order 2009^b.
3. Without prejudice to the validity of anything done or to any liability incurred by the coming into operation of this Order, the Order of 2009, as amended, shall have affect as though:
 - (a) in Article 3(1) the definition of “parking space” is substituted with the following definition:
“parking space” means a space in a parking place referred to in the Schedules to this Order which is provided for the leaving of vehicles;
 - (b) in Articles 4(1), 5(1), 6(2), 7(1), 24(3), the text “7A,” is inserted into the list of Schedules;
 - (c) in Article 7(8) the words “Schedule 7” are substituted with the words “Schedule 7 and 7A”;
 - (d) in Article 9(3) the words “Schedules 5, 6, 7 and 8” are substituted with the words “Schedules 5, 6, 7, 7A and 8”;
 - (e) in Article 26 (3) the words “Schedules 3, 4, 6, 7 and 8” are substituted with the words “Schedules 3, 4, 6, 7, 7A and 8”; and
 - (f) a Schedule 7A was added to the Order as detailed in Schedule 1 to this Order.

SCHEDULE 1

In relation to a parking place referred to in this Schedule, the expression “permitted hours” means the period between 9am and 8pm on Mondays to Sundays inclusive, any such day not being a public or bank holiday.

Parking places in respect of which a vehicle may be left during the permitted hours if it displays a valid residents’ permit or a valid residents’ visitor parking card.

(This Note is not part of the Order, but is intended to indicate its general purport.)

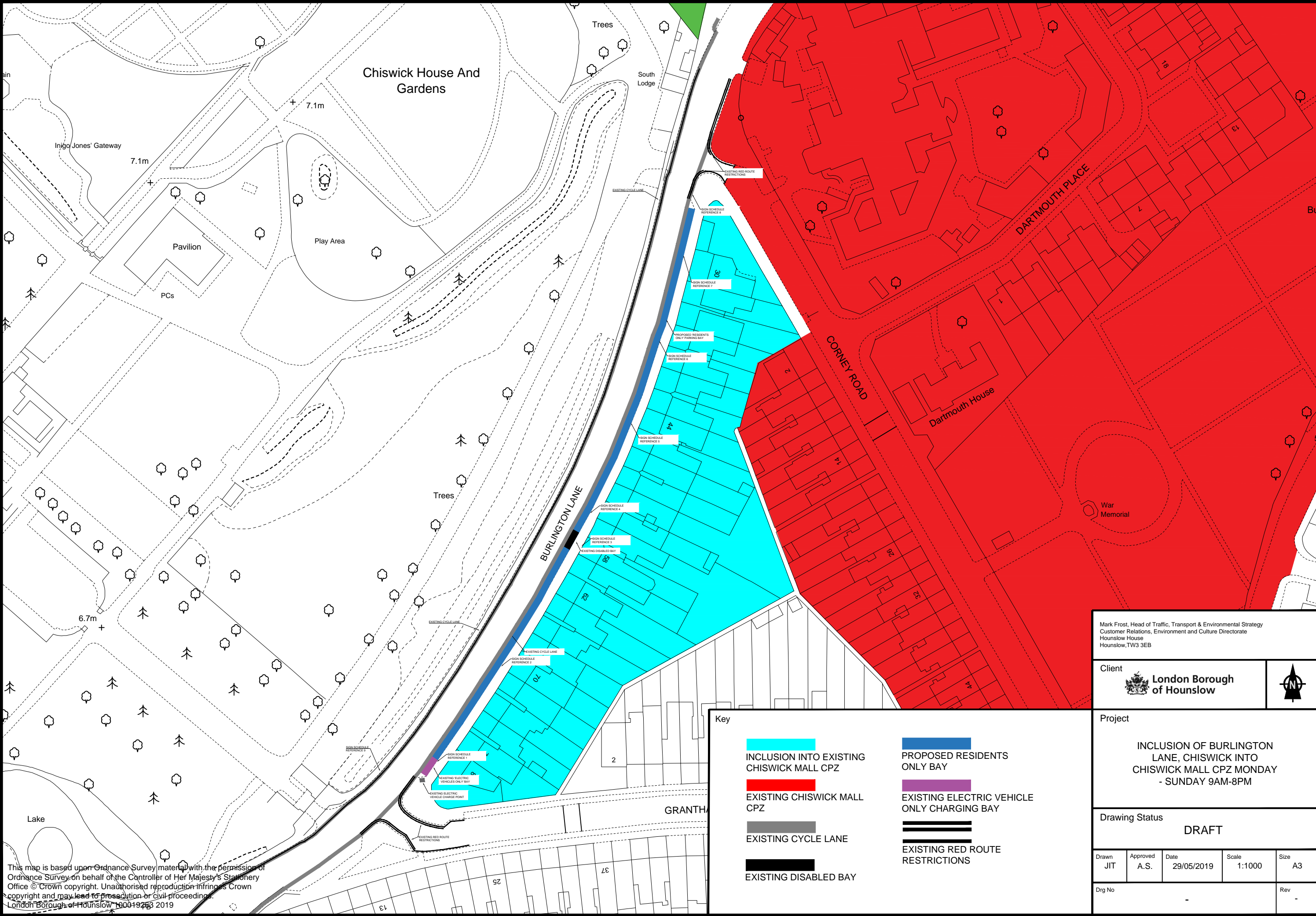
This Order amends the Order of 2009 by implementing resident parking places in the lay-by fronting Nos. 30-80 Burlington Lane, Chiswick which operate between 9am to 8pm Mondays to Sundays.

STATEMENT OF REASONS

Burlington Lane, Chiswick – proposed extension of Chiswick Mall controlled parking zone

Following an informal consultation which showed a high level of support for parking controls from respondents along this road, the Council introduced a trial extension of the existing Chiswick Mall Controlled Parking Zone which incorporated the lay-by fronting Nos. 30-80 Burlington Lane Chiswick, in order to provide a parking facility for residents and users of local businesses.

This trial was supported by residents, and the Council is now proposing to make the scheme permanent. Any objections received will be reported to a Chief Officer who, in consultation with local ward councillors, will make the decision whether the scheme should be made permanent or removed.
