Proposed removal of waiting restrictions: Sherborne Road, Feltham

A. The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.*) Order 20****

1. The London Borough of Hounslow proposes to make the above Order under the Road Traffic Regulation Act 1984.
2. The general effect of the Order would be to remove the existing no waiting “at any time” restrictions (double yellow lines) on both sides of Sherborne Road, from the boundary of Nos.10/12 north-eastwards to the closed end of the road.

4. The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 to the Road Traffic Regulation Act 1984¹ as amended, and of all other enabling powers hereby make the following Order:

- 1 This Order shall come into operation on ** ***** 20** and may be cited as the London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.***) Order 20**.
- 2 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hounslow (Waiting and Loading Restriction) Order 2008² shall have effect as though:
 - a. the item numbered 905 in Schedule 1 to that Order was substituted with the item similarly numbered and set out in the Schedule to this Order.

Statement of Reasons

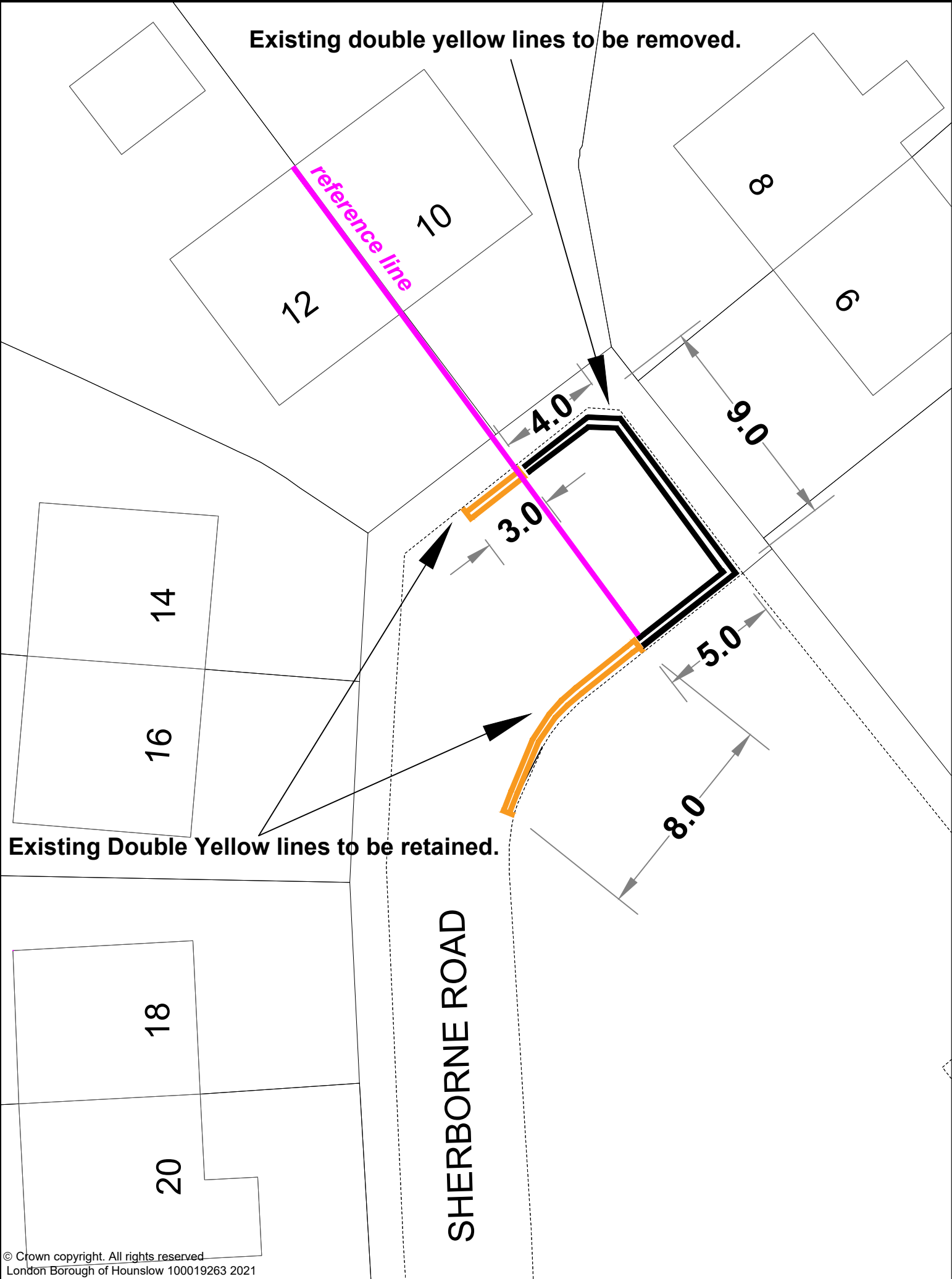
Proposed removal of double yellow lines in Sherborne Road, Feltham

The Council has received a petition from residents of Sherborne Road, Feltham to remove no waiting "at any time" restrictions (double yellow lines) in Sherborne Road, Feltham at the end of the cul-de-sac fronting Nos. 6 to 12 Sherborne Road to provide additional parking spaces for residents who are finding it increasingly difficult to park near their homes.

Additionally, the removal of the waiting restrictions will not impact emergency vehicle access as it is at the end of a cul-de-sac and furthermore, due to the barriers around the grass area it will-would be difficult for them to turn even with the restrictions in place.
