Proposed amendments to Boston Manor, Brentford East and Northumberland Estate Controlled Parking Zones

- A. The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.**) Order 20**
- B. The London Borough of Hounslow (Boston Manor) (Parking Places) Order 20**
- C. The London Borough of Hounslow (Brentford East) (Parking Places) Order 20**
- D. The London Borough of Hounslow (Northumberland Estate) (Parking Places) Order 20**
- The London Borough of Hounslow proposes to make the above Orders under the Road Traffic Regulation Act 1984.
- The general effect of the Waiting and Loading Order would be to:
 - a) Introduce "no waiting at any time" restrictions (double yellow lines) in the following roads: Beaufort Gardens, Heston; Benedict Drive, Bedfont; Brayborne Drive, Isleworth; Cottington Road, Hanworth; Dukes Avenue, Hounslow; Enfield Road, Brentford; Gabriel Close, Hanworth; Hamilton Road, Feltham; Hawthorn Hatch. Brentford; Helen Avenue, Feltham; Heston Road, Heston; Lewin Terrace, Bedfont; Ludlow Road, Feltham; Manor Vale, Brentford; Morris Road, Isleworth; Nallhead Road, Hanworth; New Close, Hanworth; Newlands Close, Heston; Old Park Mews, Heston; Page Road, Bedfont; Park Avenue, Hounslow; Pates Manor Drive, Bedfont; Poole Court Road, Hounslow; Quakers Lane, Isleworth; Ridgeway Road North, Isleworth; Rollit Crescent, Hounslow; Saxon Avenue, Feltham; Scott Gardens, Heston; Shelson Avenue, Feltham; Shelson Parade, Feltham; Sandy Drive, Bedfont; Southville Crescent, Bedfont; St Dunstans Road, Feltham; Staines Road, Bedfont; Thatchers Way, Isleworth; The Greenway, Hounslow; Triangle Way, Chiswick; Wheatlands, Heston; Wheatley Road, Isleworth; and
 - b) Introduce "no waiting" restrictions (single yellow lines) in the following roads: Albury Avenue, Isleworth; Blackberry Farm Close, Heston; Manor Vale, Brentford; Southville Crescent, Bedfont; Springvale Avenue, Brentford.
- 3. The general effect of the Boston Manor Parking Places Order would be to reduce the length of parking bay outside Nos 55-60 Manor Vale by 1.2 metres, to accommodate the increased length of proposed "no waiting" (single yellow line) restrictions.
- 4. The general effect of the Brentford East Parking Places Order would be to reduce the length of the parking bay outside Nos 25 and 27 Springvale Avenue, to accommodate the increased length of proposed "no waiting" (single yellow line) restrictions.
- 5. The general effect of the Northumberland Estate Parking Places Order would be to reduce the length of the parking bay outside No. 36 Albury Avenue, to accommodate the increased length of proposed "no waiting" (single yellow line) restrictions

- 7. STATEMENT OF REASONS

In response to complaints of obstructive and indiscriminate parking, the council are proposing to introduce a combination of 'at any time' double yellow line and single yellow line (of varying operational times) waiting restrictions at various locations throughout the borough.
