THE CPZ PROPOSALS INCORPORATE BOTH ADOPTED PUBLIC HIGHWAYS, I.E. BURFORD ROAD, AND HOUNSLOW HOUSING AREAS, I.E. BOULTON HOUSE. THE VAST MAJORITY OF THE HOUNSLOW HOUSING AREAS HAVE PARKING BAYS AND YELLOW LINES MARKED, HOWEVER, THESE ARE SHOWN AS PROPOSED ON THE PLAN FOR IDENTIFICATION PURPOSES.

'PERMIT HOLDERS ONLY PAST THIS POINT' AREA, MEANS THAT NO PARKING BAYS OR YELLOW LINES WILL BE MARKED AND RESIDENTS WILL BE ENCOURAGED TO UTILISE THE AVAILABLE SPACE WITHOUT CREATING OBSTRUCTIONS OR COMPROMISING SAFETY FOR OTHER ROAD USERS OR PEDESTRIANS.
