The Council of the London Borough of Hounslow, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 51 and 124 of the Road Traffic Regulation Act 1984^a as amended, and of all other enabling powers make the following Order:

- This Order may be cited as the London Borough of Hounslow (Chiswick Mall) (Parking Places) (Amendment No.**) Order 20** and shall come into operation for all purposes on ** ***** 20**.

Without prejudice to the validity of anything done or to any liability incurred in respect to any act or omission before the coming into operation of this Order, the London Borough of Hounslow (Chisiwck Mall) (Parking Places) (No.9) Order 2009^b, as amended, shall have affect as though the item numbered 31 in Schedule 7 to that Order is substituted with the item similarly number in the Schedule to this Order.

(This Note is not part of the Order, but is intended to indicate its general purport.)

London Borough of Hounslow (Chiswick Mall) (Parking Places) (No.9) Order 2009 designates parking places in British Grove Passage at which charges may be made by the Council for vehicles authorised by that Order to be left in those parking places during the permitted hours.

This Order amends the Order of 2009 to facilitate a vehicle crossover at Island House, Chiswick Mall, Chiswick.

- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hounslow (Waiting and Loading Restriction) Order 2008² shall have effect as though the item numbered *** in Schedule 1 to that Order were substituted with the item similarly numbered and set out in the Schedule to this Order.

This Order further amends the Hounslow (Waiting and Loading Restriction) Order 2008 by amending waiting restrictions in North Drive, Hounslow, to facilitate the provision of a new vehicle crossover at No.63 North Drive, Hounslow.
