## SECTION 247 TOWN AND COUNTRY PLANNING ACT 1990

**THIS ORDER** is made by the London Borough of Hounslow ("the Council"), acting in its capacity as a local highway authority, in exercise of its powers under Section 247 of the Town and Country Planning Act 1990 as amended ("the Act") and any other enabling powers.

## **BY THIS ORDER**

- The Council authorises the stopping up of highways at the Land at 69-76 High Street (Heidelberg), London, TW8 0AA shown hatched and edged in black over land shaded blue on the annexed plan as the Council is satisfied that this is necessary in order to enable the development described in the Schedule to this Order to be carried out in accordance with the Planning Permission bearing reference P/2022/1142 granted by the Council on 10th November 2022.
- 2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of highway authorised to be stopped up pursuant to this Order, then subject to Section 261(4) of the Act, those undertakers shall have the same rights in relation to that apparatus after the making of this Order as they had before.
- This Order shall come into force on the date on which notice that it has been made is first published in accordance with section 252(10) of the Act and may be cited as the Land At Montgomery's Wharf, Stopping Up Order 2023.

### THE SCHEDULE

### Description of Highway to be Stopped Up

There are two areas proposed to be stopped up and these are located along the southern boundary of the site, adjacent to Point Wharf Lane, which forms part of the northern side of the Thames Path. The two areas to be stopped up are:

- i. Eastern area: 4.71m in width and 27.02m in length; and
- ii. Western area: 6.64m in width and 34.44m in length.


