School Streets and Red Routes

- A. The London Borough of Hounslow (School Streets) (Amendment No.4) Order 2023
- B. The London Borough of Hounslow (Red Routes) (Amendment No.4) Order 2023
- C. The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.318) Order 2023
- The London Borough of Hounslow hereby gives notice that on 19 April 2023 it made the above Orders under the Road Traffic Regulation Act 1984. The Orders will come into operation on 22 May 2023.
- 2. The general effect of the School Streets Order will be to prohibit motor vehicles from using the following roads:
 - a) between the hours of 8.15am and 9.15am, and 2.45pm and 3.45pm, Mondays to Fridays during school term time:
 - i) Cardinal Road, Feltham;
 - ii) Norman Avenue, Hanworth;
 - iii) Towfield Road, Hanworth;
 - iv) Braid Close, Hanworth;
 - v) Cecil Road, Hounslow, between its south-western closed end and the property boundary of Nos 67 and 69;
 - vi) Denbigh Road, Hounslow;
 - vii) Tiverton Road, Hounslow, between its junction with Denbigh Road and Ellington Road.
 - viii) The Ride, Brentford;
 - ix) Clitherow Road, Brentford;
 - x) Queens Terrace, Isleworth;
 - b) between the hours of 8.30am and 9.15am, and 3pm and 3.45pm, Mondays to Fridays during school term time, Woodfield Road, between its junction with Chaucer Avenue and its southern closed end.

Exemptions will apply for emergency services vehicles, residents who live within the zone, visitors to residents within the zone, Blue Badge holders, delivery vehicles, and school staff.

- 3. The general effect of the Red Routes Order will be to introduce:
 - a) "no stopping at any time" restrictions (double red lines) restrictions in Hanworth Road and Cardinal Road, Feltham; Berkeley Avenue, Chaucer Avenue and Woodfield Road, Cranford; Boston Manor Road and The Ride, Brentford; and
 - b) "no stopping" restrictions (single red lines), Mondays to Fridays, 8.30am to 9.15am, and 3pm to 3.45pm in Berkeley Avenue, Cranford.
- 4. The general effect of the Waiting and Loading Order will be to revoke those waiting restrictions which would be replaced by Red Route restrictions.
- 5. Documents giving further information of the proposed Orders can be viewed for a period of six days from the date of this Notice online at hourslow.gov.uk by typing in the term "traffic notices" in the search bar.

Any person desiring to question the validity of the Orders or any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make an application for the purpose to the High Court.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order further amends the Hounslow (Waiting and Loading Restriction) Order 2008 by removing waiting and loading restrictions, where they have been replaced by Red Route restrictions in Boston Manor Road and The Ride, Brentford; Cardinal Road and Hanworth Road, Feltham; Woodfield Road, Cranford.
