- 1. The London Borough of Hounslow proposes to make the above Orders under the Road Traffic Regulation Act 1984.
- The general effect of the Parking Places and Waiting and Loading Orders would be to amend the existing Brentford Station (BStn) controlled parking zone (CPZ) to incorporate additional parking places in place of existing waiting restrictions in Brook Lane North, Glenhurst Road, Orchard Road and York Road.

This Order further amends the Hounslow (Waiting and Loading Restriction) Order 2008 by amending waiting restrictions in Brook Lane North, Glenhurst Road, Orchard Road and York Road, Brentford.



STATEMENT OF REASONS

Proposed Brentford Station Area Controlled Parking Zone (parking, waiting and loading amendments)

Further to a parking review carried out within the Brentford Station Controlled Parking Zone, The Council is proposing to introduce additional resident permit parking spaces in Orchard Road, Glenhurst Road, and Brook Lane North. The proposals also introduce shared-use parking spaces for resident permit holders and pay by phone users in Glenhurst Road and York Road.

The Council are also proposing to introduce no wating at any time restrictions (double yellow lines) in Brook Lane North at the junctions with York Road and Batlic Avenue as part of The Council junction protection programme.

Proposals also include the reduction of existing double yellow lines on Orchard Road to a single yellow line restriction operating on Mondays to Saturdays between the hours of 8am and 6pm as a temporary measure until the development at Orchard Road car park is complete.
