Waiting and loading restrictions - Various Roads

- A. The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.323) Order 2023
- B. The London Borough of Hounslow (Red Routes) (Amendment No.5) Order 2023
- C. The London Borough of Hounslow (Twickenham Stadium Event Day) (Parking Places) (Amendment No.9) Order 2023
- The London Borough of Hounslow hereby gives notice that on 18 May 2023 it made the above Orders under the Road Traffic Regulation Act 1984. The Orders will come into operation on 10 June 2023
- 2. The general effect of the Waiting and Loading Order will be to:
 - a) Introduce "No waiting at any time" restrictions in Baber Drive and Byward Avenue, Feltham; Watermead and Winslow Way, Hanworth; Burnham Gardens, Clevedon Gardens and Mornington Crescent, Cranford; Sutton Way, Heston; Bath Road, Neville Close and Newcombe Gardens, Hounslow; Avenue Road, Grove Road and Market Place, Brentford; and Napier Road, Ruskin Road, Twickenham Road and Woodland Gardens, Isleworth; and
 - b) Introduce "No waiting and no loading at any time" restrictions in Amberley Way, Hounslow and Macfarlane Lane, Isleworth.
- The general effect of the Red Routes Order will be to extend the "No stopping at any time" Red Route restrictions as currently marked on Macfarlane Lane, Isleworth.
- 4. The general effect of the Twickenham Stadium Event Day Parking Places Order will be to remove short lengths of parking bays to accommodate new waiting restrictions in Napier Road and Twickenham Road, Isleworth.
- 5. Documents giving further information of the proposed Orders can be viewed for a period of 6 weeks from the date of this Notice online at hourslow.gov.uk by typing in the term "traffic notices" in the search bar.
- 6. Any person desiring to question the validity of the Orders or any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make an application for the purpose to the High Court.

The London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.323) Order 2023

Made on 18 May 2023 Coming into operation on 10 June 2023

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 to the Road Traffic Regulation Act 1984¹ as amended, and of all other enabling powers hereby make the following Order:

- This Order shall come into operation on 10 June 2023 and may be cited as the London Borough of Hounslow (Waiting and Loading Restriction) (Amendment No.323) Order 2023.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The London Borough of Hounslow (Waiting and Loading Restriction) Order 2008² shall have effect as though
 - a. the items numbered 18, 47, 352, 373, 578, 665, 668, 912, 926, 928, 995, 1005, 1009, 1143, 1306, 1328, 1507 1508 and 1509 in Schedule 1 to that Order were substituted with the items similarly numbered and set out in Schedule 1 to this Order; and
 - b. the items numbered 229 and 230 in Schedule 2 to that Order were substituted with the items similarly numbered and set out in the Schedule 2 to this Order

STATEMENT OF REASONS

In response to complaints of obstructive and indiscriminate parking, the council are proposing to introduce waiting restrictions at various locations throughout the borough.
