

LICENSING ACT 2003 - SCHEDULE OF FEES

Fees in respect of applications to grant and vary an existing licence

Fees for the grant of a new licence and for the variation of an existing licence (except an application to vary the name of the designated premises supervisor) are set by central government; and the non-domestic rateable value of the applicant premises determines which of the five fee bands is applicable.

Premises that do not have a non-domestic rateable value, for example parks and open spaces, fall into Band A. Premises that form part of larger premises should use the non-domestic rateable value of the larger premises to determine the fee band. Premises that consist of two more areas with different non-domestic rateable values pay the fee for the band of the premises with the greatest non-domestic rateable value only.

Every application, except those made in respect of an "exempt premise", must pay the base fee shown in the Table 1.

Furthermore applications in respect of premises that fall in Bands D and E that are used primarily for the sale of alcohol for consumption on the premises attract the additional fee shown in the final column of Table 1.

In addition to the base fee, and where applicable additional fee, premises that have the capacity to accommodate more that 5000 people must pay a supplementary as detailed in Table 2.

Who is exempt from paying the fee?

Applications made in respect of a school, college, church, church hall or community hall that are used solely for the purposes of providing **regulated entertainment** are exempt from the fee if the following conditions are met:

1. The holder of the premises licence or club premises certificate is:

(a) the proprietor of an educational institution which is a school or college; and
(b) the licence or certificate has effect in respect of premises that are or form part of the educational institution; and
(c) the provision of regulated entertainment on the premises is carried on by the

- educational institution for and on behalf of the purposes of the educational institution; or
- 2. That the premises licence or club premises certificate has effect in respect of premises that are or form part of a church hall, chapel hall or other similar building or a village hall, parish hall or community hall or other similar building.

There are no other fee reductions available, not even for charitable or non-profit making events.

Will I get a receipt?

If you post your application to the Licensing Team you will only be issued a receipt if you specifically request one and enclose a self-addressed envelope with the application.

How much will it cost each year for the licence

Table 3 details the fee you have to pay each year. This fee is due one year after the issue of the licence. You will be offered the opportunity to set up a direct debit for the collection of the annual fee.
