The London Borough of Hounslow (in this Order called the “Acquiring Authority”) hereby makes the following Order:

1. Subject to the provisions of this order, the Acquiring Authority is under section 226(1)(a) of the Town and Country Planning Act 1990 and section 13(1) of the Local Government (Miscellaneous Provisions) Act 1976 hereby authorised to purchase compulsorily the land and the new rights over land described in paragraph 2 for the purpose of facilitating the carrying out of development, redevelopment or improvement of that land which the Acquiring Authority considers will contribute to the promotion and improvement of the economic, social and environmental wellbeing of the area by enabling the delivery of a residential led development comprising affordable dwellings, retail and commercial floorspace and hard and soft landscaping.
2. (1)The land authorised to be purchased compulsorily under this Order is the land identified in the column headed ‘Extent, Description and Situation of the Land’ in Table 1 of the Schedule hereto and delineated and shown coloured pink on the Map, prepared in duplicate, sealed with the common seal of the Acquiring Authority and marked “Map referred to in The London Borough of Hounslow (Charlton House and Albany House) Compulsory Purchase Order 2023”.

(2)The new rights to be purchased compulsorily over the land under this order are described in the Schedule and the land is shown in delineated and shown coloured blue on the said map.




