**THIS ORDER** is made by the London Borough of Hounslow ("the Council"), acting in its capacity as a local highway authority, in exercise of its powers under Section 247 of the Town and Country Planning Act 1990 ("the Act") as amended and any other enabling powers

#### BY THIS ORDER

- 1. The Council authorises the stopping up of highway at The Dell, Feltham, TW14 0JF as described in Schedule 1 of this Order and shown edged in red on the attached drawing as the Council is satisfied that this is necessary in order to enable the development described in Schedule 2 to this Order to be carried out in accordance with the planning permission granted under Part III of the Act by the Council on 4 February 2022 under planning reference number P/2021/0376 (00342/A/P1).

Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of highway authorised to be stopped up pursuant to this Order, then subject to Section 261(4) of the Act, those undertakers shall have the same rights in relation to that apparatus after the making of this Order as they had before.
- 3. This Order shall come into force on the date on which notice that it has been made is first published in accordance with section 252(10) of the Act and may be cited as The Dell, Feltham, TW14 0JF Stopping Up Order 2024.
