If you wish to apply for relief, please complete the form, and return it to the council.

The qualification criteria for the awarding of Small Business Relief is shown below:-

- 1) You occupy a non-domestic property with a rateable value of below £51,000 (£25,500 prior to 01.04.17)
- 2) The property has not been awarded, or would be entitled to mandatory relief
- 3) Any secondary occupied non-domestic property in England has an individual rateable value of below £2,900, or is empty (£2,600 prior to 01.04.17)
- 4) The total of all your occupied non-domestic property in England is below £28,000 (£25,500 prior to 01.04.17)

If ALL of the above criteria is met, you will be entitled to relief.

All occupied property with a rateable value below £51,000 (that is also not entitled to mandatory relief) will have its liability calculated using the lower small business multiplier. Therefore you do not need to complete this application if your rateable value is £15,000 or over.

If you qualify, the following amounts of relief will currently be awarded from 01.04.17:-
