Architect



Chris has been tutor and a visiting critic at a number of universities and is a member of the Harrow Design Review Panel.

Architect

Cristina is an architect, author, and founding co-director of DK-CM, a practice of architects, researchers, and strategists working in the public realm to create spatial, environmental, and social change. In 2021, she was shortlisted for the Moira Gemmill Prize in recognition of excellence in design for women designers under 45. Cristina has extensive experience working with public sector clients, particularly on delivering adaptive reuse and retrofit projects. Notable projects include the adaptive reuse of Harrow Arts Centre, Rebel Business School, Wroughton Academies, and currently, the retrofitting of Kilburn Mews and the Camber Sands Welcome Centre.
