**Proposed Speed Table Ridgeway Road, Isleworth**

1. NOTICE IS HEREBY GIVEN that The London Borough of Hounslow propose, under Section 90A of the Highways Act 1980, to construct a flat-top road hump (also known as a “speed table”) in Ridgeway Road, Isleworth, at its junction with College Road, situated:-
  - a) On the eastern kerbline 2.68m east of the building line of No. 22 College Road, Isleworth; &
  - b) On the western side kerbline 4.85m south of the building line with No. 4 Ridgeway Road, Isleworth.
2. The flat-top road hump would extend across both sides of Ridgeway Road, Isleworth with a maximum height of 75mm, maximum centreline plateau length of 9.97m, and a maximum front and rear slope of 1 in 12, as per the below table:
