ANY OBJECTION to the making of the proposed Order must be made in writing within a period of 28 days commencing on 11th October 2024 by writing to the Assistant Director, Transport and Parking, London Borough of Hounslow, 7 Bath Road, Hounslow, TW3 3EB quoting reference: 'New Road Stopping Up Order 2024'.

The Council may disclose the substance of any objection made to the making of the Order to other persons affected by it and that those persons may wish to communicate with the objector.

If no objections are duly made to the making of the Order, or if any objections are withdrawn, the Council may make the Order as an unopposed Order. Any objections duly made and which are not withdrawn will be referred to the Mayor of London.

Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of highway authorised to be stopped up under this Order then, subject to Section 261(4) of the Act, those statutory undertakers shall continue to have the same rights in respect of that apparatus after that area of highway is stopped up as they had immediately before the making of this Order.
- 3. References to the "**Deposited Plan**" shall mean the plan numbered 1758-ISS-XX-XX-DR-S-0554 P03 deposited at the main reception London Borough of Hounslow, Hounslow House, 7 Bath Road, Hounslow, TW3 3EB.
