Staff will wear face masks and maintain hygiene protocols at all times. Customers will be encouraged to take food away and not gather around the trading unit. These measures aim to reduce crowding and provide a safe and efficient customer experience

- Outline how local nuisance will be managed. At Carlos Takeaway Van, we are committed to operating responsibly and ensuring our presence does not cause any nuisance to the local community. The following measures will be taken: 1. Noise Control No amplified music or shouting will be permitted. Staff will monitor noise levels during trading hours, especially in the evening. 2. Litter Management Waste bins will be provided for customer use. Staff will regularly clean around the van to ensure no litter is left in the vicinity. 3. Queue Management Clear signage will be used to organise queuing and maintain a safe, respectful environment. Customers will be reminded to maintain personal space and behave respectfully. 4. Avoiding Obstruction The pitch will be set to avoid blocking any public paths, business entrances, or driveways. Customers will be encouraged not to loiter after ordering. 5. Traffic and Parking Awareness No customers or staff will be permitted to park illegally or obstruct traffic or resident access. 6. Respect for Others Any antisocial behaviour or disturbance will not be tolerated and will be addressed immediately by staff. We believe that with these steps, our operation will remain respectful, clean, and beneficial to the local area
