M Describe any additional steps you intend to take to promote the four licensing objectives as a result of the proposed variation:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)

To promote the four licensing objectives—prevention of crime and disorder, public safety, prevention of public nuisance, and protection of children from harm—I will implement additional measures to manage the extended hours from midnight to 4 am, ensuring responsible service of hot and cold food during this late-night period. The outdoor seating area with two tables and six chairs will be regularly supervised and maintained to prevent litter and disturbance. Staff will be trained to manage customer behavior effectively during these later hours, minimizing noise and preventing disorderly conduct. Enhanced lighting and CCTV coverage will be in place around the outdoor seating to improve safety and deter crime.

b) The prevention of crime and disorder

To prevent crime and disorder during the extended hours, we will ensure the outdoor seating area is well-monitored with CCTV and adequate lighting. Staff will be trained to identify and manage any potentially problematic behaviour promptly, refusing service to anyone causing disturbances. We will work closely with local authorities to maintain a safe environment and deter any criminal activity.

c) Public safety

We will ensure that all furniture in the outdoor area is safely arranged to prevent hazards, maintain clear access for emergency services, and regularly inspect the premises to address any potential safety promptly during the extended hours.

d) The prevention of public nuisance

To prevent public nuisance, we will implement measures to minimize noise from customers using the outdoor seating, including setting clear guidelines for behaviour and encouraging quiet conduct during late hours. We will also ensure prompt litter removal and monitor the area to avoid disturbance to nearby residents.

e) The protection of children from harm

To protect children from harm, we will strictly enforce age restrictions on alcohol sales and ensure that children are not permitted in the premises during the late-night hours when the licence is extended. Staff will be trained to challenge underage individuals and prevent access to restricted areas.
