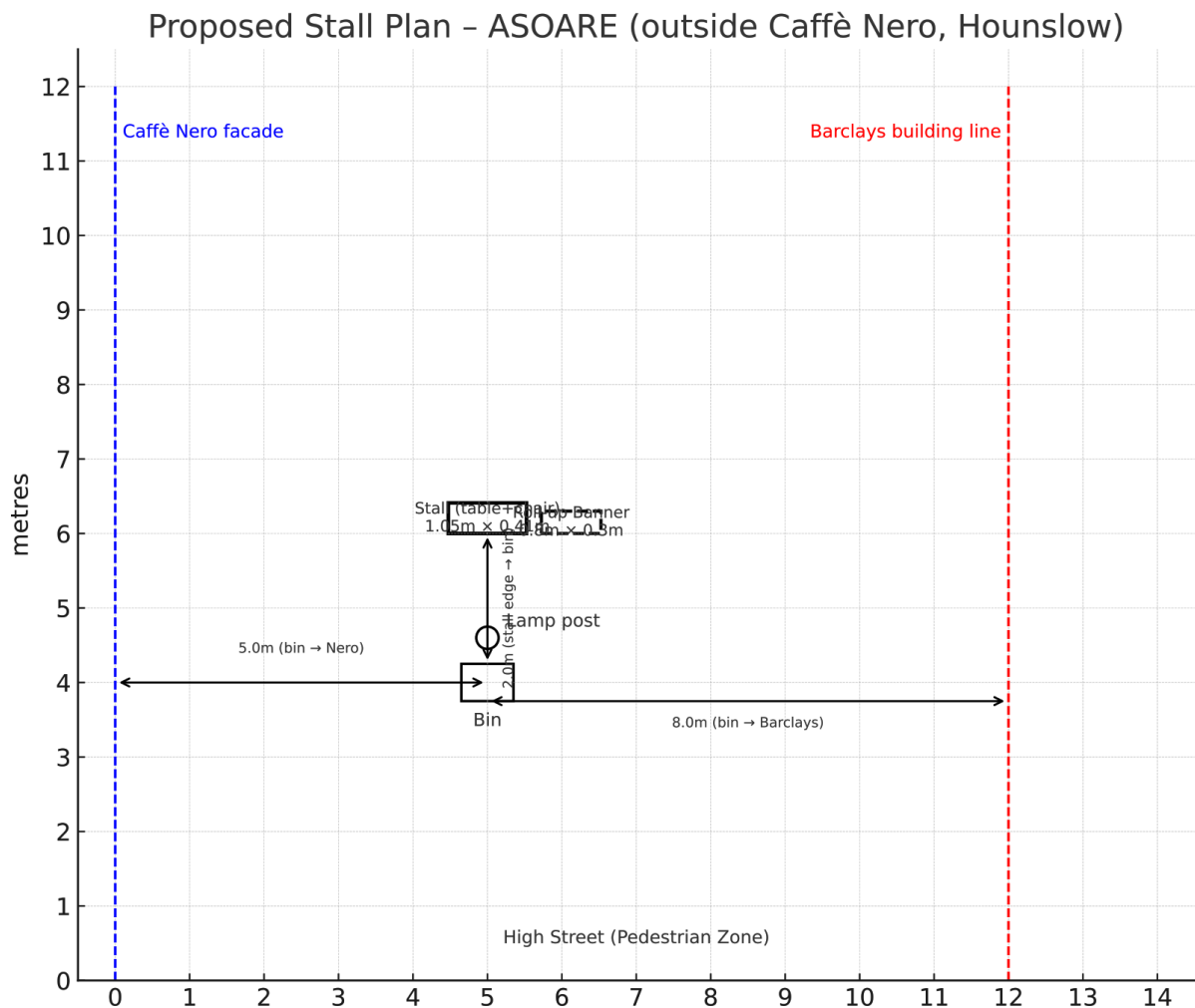

Please find attached my plan showing the proposed stall area outside Caffè Nero on Hounslow High Street, with all the required measurements and distances clearly marked. For clarity, here are the details also in writing:

- **Stall (table + chair):** 1.05 m (width) × 0.41 m (depth).
- **Roll-up banner (display object):** 0.80 m (width) × 0.30 m (depth).
- **Distances:**
 - From stall edge to bin: 2.0 m
 - From bin to Caffè Nero façade line: 5.0 m
 - From bin to opposite building line (Barclays side): 8.0 m

The location is on the pedestrianised section of the High Street, where there is sufficient space for pedestrian flow.
