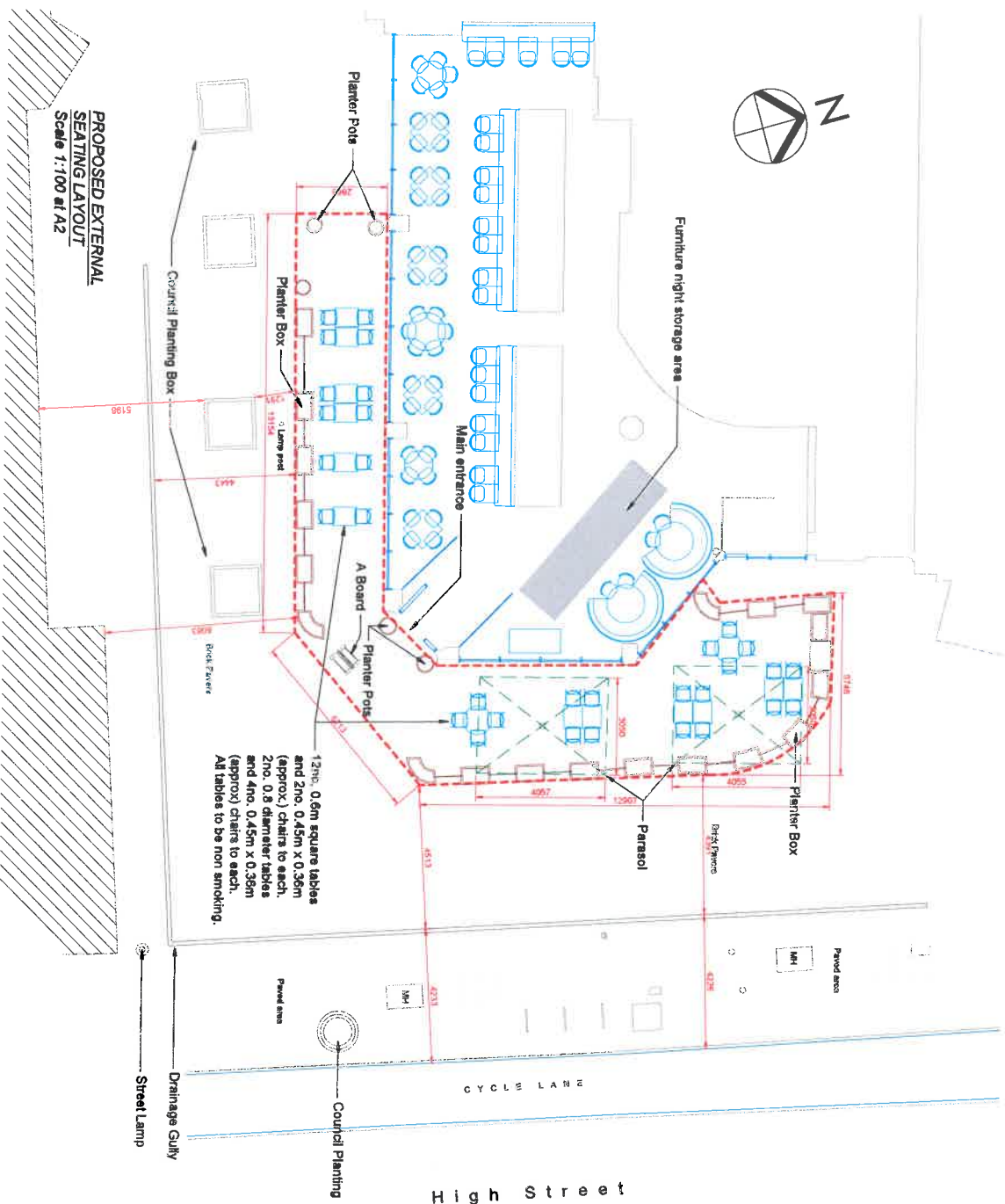

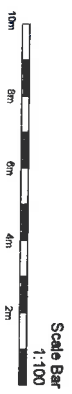

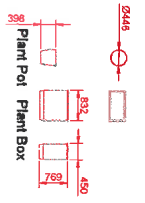


**PROPOSED EXTERNAL SEATING LAYOUT**

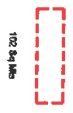
