 Order 202*
- 1. NOTICE IS HEREBY GIVEN that the London Borough of Hounslow propose to make the above-mentioned Orders, under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of these Orders would be to:
 - (a) introduce no waiting and no loading at any time restrictions on London Road, Brentford, the north-west side, outside Nos. 50-70 London Road.
- 3. The London Borough of Hounslow (Waiting, Loading and Stopping) (Amendment No. *) Order 202*

Coming into operation on ** ***** 20**

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 to the Road Traffic Regulation Act 1984^a as amended, and of all other enabling powers hereby make the following Order:

Citation and Commencement

1. This Order shall come into operation on ** ***** 20** and may be cited as The London Borough of Hounslow (Waiting, Loading and Stopping) (Amendment No. *) Order 202*.

Interpretation

- 2. (1) In this Order the "Order of 2025" means The London Borough of Hounslow (Waiting, Loading and Stopping) Order 2025^b.
 - (2) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2025 shall have the same meaning as in that Order.
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Revocation and/or Substitution and/or Addition of Prohibition and/or Restriction

- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2025 shall have effect as though:
 - (a) the item numbered 763 in Schedule 1 to that Order were substituted with the item similarly numbered and set out in Schedule 1 to this Order; and
 - (b) the item numbered 113 in Schedule 2 to that Order were substituted with the item similarly numbered and set out in Schedule 2 to this Order.



Statement of Reasons

Provision of vehicle crossover - London Road, Brentford

The proposed Orders are necessary to remove existing parking places and introduce waiting restrictions in London Road, Brentford, to facilitate the provision of a new vehicle crossover at No.50 London Road, Brentford.
