We are respectfully requesting three changes to the licence:

Sale of alcohol

We would like to be able to sell alcohol at the market. E.g. We have been approached by (a Chiswick business) about selling at the market and we would like to be able to offer Mulled wine at the Christmas market. Local businesses would have priority in providing this service.

Remove requirement of 1 metre distance between each stall

Our current licence for the period from June to December 2025 includes a new clause - Clause 21) There must be a minimum of 1 metre distance between each stall.

We believe the 1m spacing to be unnecessary for the flower market for the following reasons:

The Old Market Place has numerous escape routes as illustrated on the attached file.

Most of the flower market stalls are wide open - i.e. gazebos with open front, sides and backs which enable people to walk through. (see photos to illustrate this)

There are gaps between the stalls although not always 1m.

We would like this requirement to be removed.

Remove requirement of 1 metre distance from benches

This requirement is only relevant to the benches on the stretch of the market between Devonshire Road and Annadale Road. This limits the space for stalls in this area which makes the market disjointed.

Please note that there are other benches in close proximity near the High Road which are rarely used but can be used. In addition the new seating at Ginkgo Corner at the Linden Gardens end of the market provides a good amount of additional seating.

We would like this requirement to be removed.
