- 1. NOTICE IS HEREBY GIVEN that the London Borough of Hounslow on 12 November 2025 it made the above-mentioned Order, under Sections 6, and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Order will come into operation on 14 November 2025.
- 2. The general effect of these Orders will be to:
 - (a) make the following amendments in Twickenham Road, Isleworth:-
 - (i) relocate the existing payment parking place on the west side outside No. 231 Twickenham Road by 6.7 metres northwards and reduce the length by 6 metres;

 - (v) amend existing waiting and loading restrictions to accommodate the changes listed above.

 - (i) revoke a section of the existing permit parking place on the south side, outside Nos. 77 and 79 St Johns Road;

 - the parking places numbered 11 and 14 in Schedule 1 to that Order were substituted with the parking places similarly numbered and set out in the Schedule to this Order;

 - (b) the parking place numbered 12 in Schedule 1 to that Order is hereby revoked.



EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order further amends The London Borough of Hounslow (South Street) (Parking Places) Order 2011 by:-

- (a) relocating the existing payment parking place on Twickenham Road, Isleworth, the west side outside No. 231 Twickenham Road by 6.7 metres northwards and by reducing the length by 6 metres;
- (b) relocating the existing payment parking place on Twickenham Road, Isleworth, the west side outside No. 205 Twickenham Road by 7 metres southwards and by reducing the length by 5.5 metres; and
- (c) revoking the existing payment parking place on Twickenham Road, Isleworth, the west side outside No. 225 Twickenham Road, to be replaced by a goods vehicle loading bay.



Proposed amendments to waiting, loading bays and parking places, Twickenham Road and St Johns Road, Isleworth

STATEMENT OF REASONS

The London Borough of Hounslow is proposing to amend the Traffic Management Orders to regulate parking on Twickenham Road and St Johns Road, Isleworth. The proposals include the following on Twickenham Road: Relocate the existing payment parking place on the west side outside No. 231 Twickenham Road by 6.7 metres northwards and reduce the length by 6 metres, relocate the existing payment parking place on the west side outside No. 205 Twickenham Road by 7 metres southwards and reduce the length by 5.5 metres, revoke the existing payment parking place on the west side outside No. 225 Twickenham Road, relocate the existing goods vehicle loading place on the west side outside No. 229 Twickenham Road by 11 metres northwards, and amend existing waiting and loading restrictions to accommodate the changes listed above. The proposals include the following on St Johns Road: revoke a section of the existing permit parking place on the south side, outside Nos. 77 and 79 St Johns Road, introduce a no waiting at any time restriction on the south side, outside Nos. 77 and 79 St Johns Road, and replace a section of the existing no waiting Mon-Fri 10am-12pm and 5pm-7pm on the north side, outside No. 116 St Johns Road with a no waiting at any time restriction. The proposals are in accordance with the Road Traffic Regulation Act 1984 and form part of the Council's wider objectives to improve parking management, access, and compliance.
