No. of submissions: 17	<u>Proposal:</u> Temporary change of use of area of Gunnersbury Park for the staging of a three-day music event to be held on 13th, 14th and 15th September 2024. Set-up from 2nd September 2024 and clearance by 20th September 2024. Including erection of associated temporary structures, ancillary concessions and facilities <u>Summary of objections</u> - Too many events. A three-day event is too long. The park would be closed to the public during the events. - Roads closed; extra traffic; non-residents occupying parking spaces; damage to the roads by heavy delivery trucks. - Acton Town station is not designed or intended for use by so many people. - The allowed decibel level is too high and the measured level at the playground is over 90. - This event starts from Friday, affecting two schools nearby and the noise will harm the children. - Littering - but the organisers only clean the park area, leaving litter on the pavements etc. Vomiting, drinking around our houses. - Affect domestic animals and local wildlife. - This event last year sprayed graffiti in front of the cemetery and they are still there. <u>Summary of likely recommendation</u> - Approve with noise, transport, lighting and ecological conditions.

Proposal	Retrospective permission for the erection of a two storey house consisting of two bedrooms with associated private amenity, parking, bin and cycle storages.			
No. of submissions: 1	<u>Summary of objections</u> - Abuse of planning system. Applicant extended the original house, then sought retrospective permission and is doing so again. - Excessive in size, extended house larger than adjoining semi-detached house. - Garden of No. 33 and 33A contains a footpath that gave locals between Nene gardens and Bell Lane. It was illegally closed in the 1980's and must be reinstated. When Whiteley Court was built, neighbours were told that the old footpath would be tarmacked to provide service access to existing electrical substation it is currently accessible by foot for maintenance and is deteriorating. - Family dwellings needed. <u>Summary of reasons for approval</u> - No external alterations/ extensions to existing house, which have all received planning permission. - Site layout and design are acceptable and don't harm the appearance of the area. - The application has measures to address sustainability, transport and servicing provisions for the site and for No.33. - There is no record of any footpath within Nos. 33 and 33A Winchester Road. - The houses at both No. 33 and No.33A are in use as family dwellings. The current scheme does not propose any change in use.
