<b>No. of submissions:</b> 3	<p><b><u>Summary of objections</u></b></p> <ul style="list-style-type: none"> <li>- Two heat pumps would be undue proliferation of paraphernalia, a single unit, would be visually less intrusive for neighbours.</li> <li>- A significantly larger enclosure for the two heat pumps and would extend closer to adjoining neighbours' windows.</li> <li>- They pumps could run for at least 15-20 daily and would amplify noise and vibration for neighbours. Refrigerant leakage could cause serious distress.</li> <li>- Heat pumps should be installed at least three metres from neighbours. They should be enclosed and sound proofed.</li> </ul> <p><b><u>Summary of reasons for approval</u></b></p> <ul style="list-style-type: none"> <li>- No harm to the appearance of the area.</li> <li>- No loss harm to neighbours' outlook.</li> <li>- The submitted noise assessment is acceptable emissions can be controlled by condition</li> </ul>
