Proposal	Retrospective planning permission for installation of a two-storey double-deck bus on a concrete hardstanding to provide a school library facility. (<i>Note the bus has been purchased and is currently on school grounds as indicated in the existing drawings</i>).			
No. of submissions: 7	<p>Summary of objections</p> <ul style="list-style-type: none"> - Visual impact affecting well-being of residents and ambience of homes - red glare from the bus in habitable rooms to the rear. - Overlooking and privacy concerns from upper levels of the bus. - Suggestions to consider single storey bus instead. - Impact on parking. <p>Summary of reasons for approval</p> <ul style="list-style-type: none"> - The bus has been relocated towards the school blocks to maximise separation distances between the bus and the residences. - Windows overlooking houses on the upper level of bus to be obscure glazed. - Colour change (red to dark green RAL6001) of the top half of the side of the bus facing the residences to reduce visual impact. - Alternative location of bus on the playing fields considered but would create play and safety concerns from damage to glass. - No impact on parking expected, because the bus would be used to facilitate a library and would not increase student numbers.

No. of submissions: 1	<p><u>Summary of objections</u></p> <ul style="list-style-type: none"> - The extension is too big and too tall, and should not locate next to the existing extension of adjoining neighbours. - The flat roof could be used as a balcony. <p><u>Summary of reasons for approval</u></p> <ul style="list-style-type: none"> - The size extension aligns with the Residential Extension Guidelines, which would maintain neighbours' sunlight and privacy. - A condition can prevent the flat roof be used as a roof top balcony.
