GROUND FLOOR – Summary of Changes

The **layout and structure** of the ground floor remain consistent between the previous and updated plans. However, a **renumbering of rooms** has occurred in the updated "Existing Ground Floor Plan." No material alterations to internal walls, functional spaces, or structural footprint are evident from the comparison.
