WE PARTICIPATE IN 'NO ID NO SALE' POLICY. RELEVANT SIGNAGE WILL BE DISPLAYED CLEARLY TO EVERY CUSTOMER. ALL STAFF, WHOSE RESPONSIBILITIES INCLUDE THE SALE OF ALCOHOL WILL RECEIVE THE NECESSARY TRAINING ON CONDUCTION AND EVERY 6 MONTHS. THE TRAINING WILL INCLUDE THE UNDERSTANDING OF THE TERMS, CONDITIONS AND RESTRICTIONS OF THE PREMISES LICENCE & THE OPERATION OF THE CCTV EQUIPMENT & ALSO THE PREVENTION OF UNLAWFUL SALE OF ALCOHOL.

b) The prevention of crime and disorder

PREMISES WILL BE INSTALLED WITH 24-HOUR CCTV RECORDING ON LICENSED PRODUCTS AND CUSTOMER SERVICE AREAS. REFUSAL REGISTER WILL BE KEPT IN THE RESTAURANT TO NOTE ALL THE UNDERAGE ATTEMPTS TO BUY ANY AGE RESTRICTED GOODS. WE WILL MAKE SURE THE CCTV SYSTEM SERVING THE PREMISES WILL BE MAINTAINED FULLY OPERATIONAL AND IN GOOD WORKING ORDER AT ALL TIMES & THE SYSTEM WILL BE ABLE TO MAKE AND RETAIN CLEAR IMAGES.

c) Public safety

ALL NECESSARY STEPS WILL BE TAKEN TO ENSURE ALL THE FIRE & SAFETY REGULATIONS ARE ACTIVE AND ADHERED TO AT ALL TIMES. FIRE FIGHTING EQUIPMENTS ARE INSTALLED AND EASILY ACCESSIBLE. WE WILL KEEP RECORDS WRITTEN IN ENGLISH WITH THE DATE, TIME AND CIRCUMSTANCES OF ANY CHALLENGES MADE IN ACCORDANCE WITH THE "CHALLENGE 25" SCHEME & DISORDER, EJECTION OR OTHER RELEVANT INCIDENT THAT OCCURS ON THE PREMISES. THIS BOOK OF RECORDS WILL BE KEPT ON THE PREMISES AT ALL TIMES.

d) The prevention of public nuisance

PROUDIENT SIGNAGE WILL BE IN DISPLAY ADVISING CUSTOMERS NOT TO GATHER IN LARGE NUMBERS IN OR OUTSIDE THE PREMISES, EXCEPT SEATED INSIDE. CCTV WILL BE IN OPERATION 24 HOURS AND ANY CUSTOMERS CAUSING NUISANCE WILL BE ADVISED TO RESPECT NEIGHBOURS. FRONT AND REAR OF THE PREMISES ARE KEPT LITTER FREE AT ALL TIMES. NO ALCOHOL PRODUCTS ARE ALLOWED TO BE CONSUMED OUTSIDE THE PREMISES. ALCOHOL CONSUMPTION IS ONLY ALLOWED INSIDE THE PREMISES WITH FOOD.

e) The protection of children from harm

WE PARTICIPATE IN "CHALLENGE 25" AND "NO ID NO SALE" POLICY, SO THAT CHILDREN HAVE NO ACCESS TO ANY AGE RESTRICTED PRODUCTS. CHILDREN ARE ALLOWED INTO THE RESTAURANT ONLY WITH ACCOMPANYING ADULTS. WE WILL OPERATE "CHALLENGE 25" AGE VERIFICATION POLICY AT THE PREMISES. ANY PERSONS WHO APPEARS UNDER 25 YEARS OF AGE WILL BE REQUESTED TO PROVIDE ACCEPTABLE FORM OF ID SUCH AS PASSPORT OR UK PHOTO DRIVING LICENCE.




