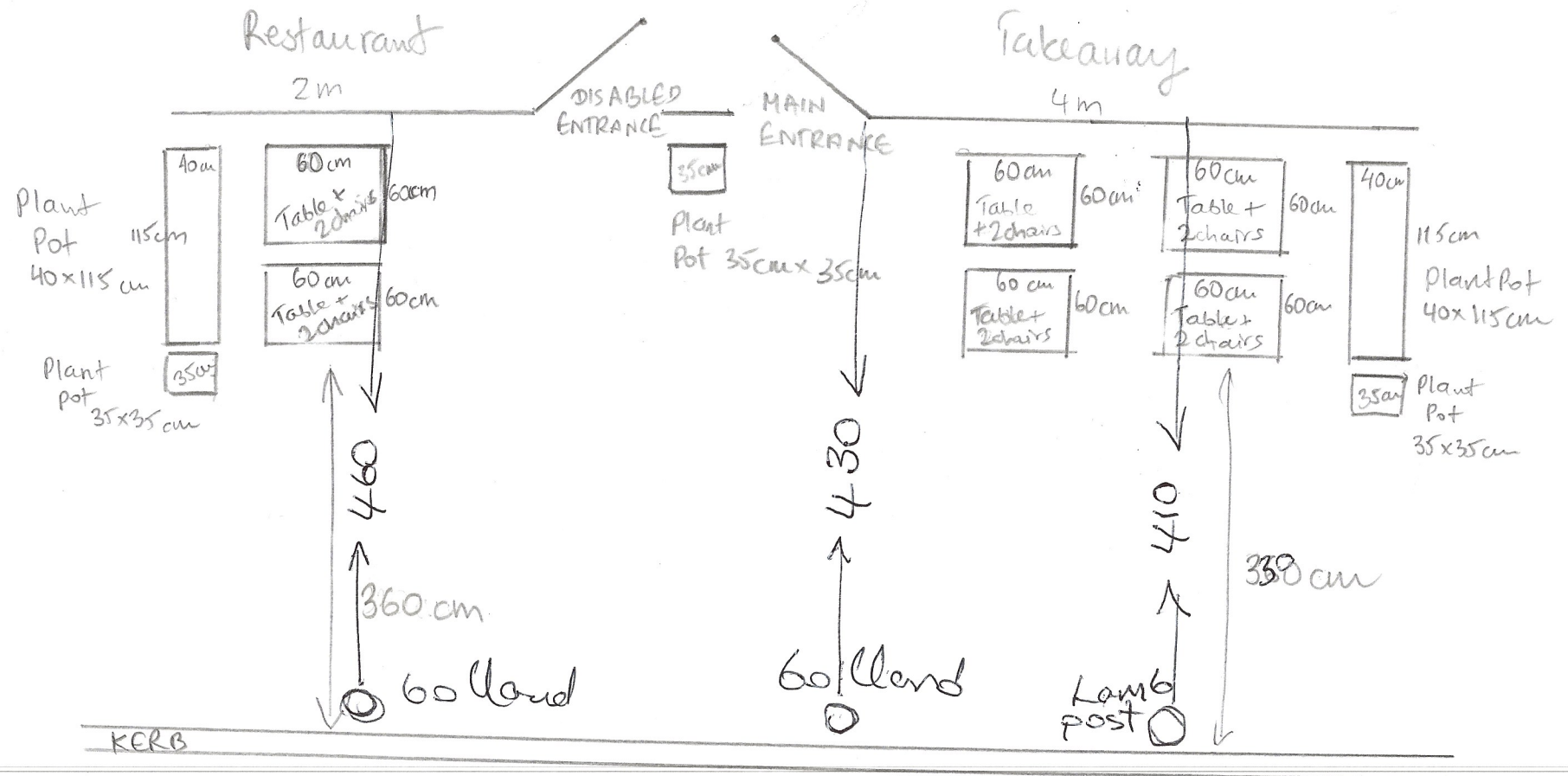

No furniture will be left outside overnight.

Staff will supervise the pavement area throughout service, ensuring customers remain within the licensed boundary, walkways are kept clear, and noise levels are appropriately managed, particularly in the evening. Any spillages or hazards will be dealt with immediately. No music will be played in the outside area. Any issues raised by members of the public or council officers will be addressed promptly by the responsible manager on duty
