1. NOTICE IS HEREBY GIVEN that the London Borough of Hounslow propose to make the above-mentioned Orders, under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

  - (p) relocate the existing payment parking place on High Street, Brentford, south-east side, adjacent to Lewis House, West Bradbury Yard by 1.5 metres in a north-easterly direction;
  - (q) revoke the existing permit parking place on Marlborough Road, Chiswick, west side, adjacent to No. 367 Chiswick High Road.

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 to the Road Traffic Regulation Act 1984<sup>a</sup> as amended, and of all other enabling powers hereby make the following Order:

## Citation and Commencement

1. This Order shall come into operation on \*\* \*\*\*\*\* 20\*\* and may be cited as The London Borough of Hounslow (Waiting, Loading and Stopping) (Amendment No. \*) Order 202\*.

## Interpretation

2. (1) In this Order the “Order of 2025” means The London Borough of Hounslow (Waiting, Loading and Stopping) Order 2025<sup>b</sup>.  
(2) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2025 shall have the same meaning as in that Order.  
(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

## Revocation and/or Substitution and/or Addition of Prohibition and/or Restriction

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2025 shall have effect as though:
  - (a) the items numbered 47, 78, 89, 120, 124, 151, 164, 303, 327, 351, 414, 420, 428, 483, 513, 546, 552, 559, 595, 641, 653, 695, 696, 805, 853, 867, 910, 961, 968, 1141, 1189, 1225, 1235, 1271, 1284, 1321, 1381, 1391, 1400, 1401, and 1424, in Schedule 1 to that Order were substituted with the items similarly numbered and set out in Schedule 1 to this Order;
  - (b) the item numbered 1445, in Schedule 1 to this Order was added with items similarly numbered and set out in Schedule 1 to that Order; &

1. This Order shall come into operation on \*\* \*\*\*\*\* 20\*\* and may be cited as The London Borough of Hounslow (West Chiswick) (Parking Places) (2009, No. 13) (Amendment No. \*) Order 202\*.

## Interpretation

2. (1) In this Order the “Order of 2009” means The London Borough of Hounslow (West Chiswick) (Parking Places) (No. 13) Order 2009<sup>b</sup>.
- (2) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2009 shall have the same meaning as in that Order.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

## Revocation and/or Designation of Parking Places

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2009 shall have effect as though:
  - (a) the parking place numbered 209A in Schedule 8A to that Order was hereby revoked.

**EXPLANATORY NOTE**

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order further amends The London Borough of Hounslow (West Chiswick) (Parking Places) (No. 13) Order 2009 by revoking the existing permit parking place on Marlborough Road, Chiswick, west side, adjacent to No. 367 Chiswick High Road.

## **Proposed Amendments to Waiting Restrictions, Loading Restrictions and Parking Places – Various Locations**

### **STATEMENT OF REASONS**

In response to complaints of obstructive and indiscriminate parking, the Council are proposing to introduce “at any time” (double yellow line) waiting restrictions at various locations throughout the borough.

These restrictions are proposed in response to concerns of obstructive parking creating difficulties for other highway users, including pedestrians and the emergency services. It is anticipated that these restrictions will remove obstructive parking thereby improving traffic flow, increasing visibility, and generally improving highway safety conditions for all users.

The location of the proposed waiting restrictions are as follows:

- Argyle Avenue, Bleriot Road, Brabrazon Road, Cobham Road, Dorset Waye, Dudset Lane, Earl Haig Close, Great South-West Road, Green Lane, Hanworth Road, Johnson Road, John Street, Murray Avenue, Neville Close, Old Farm Close, Sopwith Road, Sutton Way, Wesley Avenue, West Way, Whitton Dene and Whitton Road, **Hounslow**.
- Baber Bridge Parade, Bell Lane, Benedict Drive, Foxwood Close, Pates Manor Drive and Staines Road, **Feltham**.
- Clayponds Avenue, High Street and The Ham, **Brentford**.
- Falcon Close, Grange Road, Herbert Gardens, Marlborough Road and Turnham Green Terrace, **Chiswick**.
- Sussex Avenue and Woodlands Road, **Isleworth**.
- Penbury Road, **Southall**.
- The Clumps, **Ashford**.

The location of the proposed loading restrictions are as follows:

- Dudset Lane, Green Lane, Whitton Road and Earl Haig Close, **Hounslow**.
- Baber Bridge Parade, Bell Lane and Staines Road, **Feltham**.
- High Street and The Ham, **Brentford**.
- Marlborough Road and Turnham Green Terrace, **Chiswick**.

These proposals will also impact parking bays as detailed below:



- revoking the existing permit parking place on Marlborough Road, Chiswick, west side, adjacent to No. 367 Chiswick High Road.

- relocating the existing loading bay on High Street, Brentford, north-west side, outside Booth House, High Street by 5.0 metres in a south-westerly direction.

These proposals will also impact on the free parking places as detailed below:

- relocating the existing limited waiting parking place on Argyle Road, Hounslow, north side, adjacent to No. 97 Whitton Road by 1.5 metres in a westerly direction;
- relocating the existing limited waiting parking place on Argyle Road, Hounslow, south side, adjacent to No. 99 Whitton Road by 3.0 metres in a westerly direction;
- extending the existing limited waiting parking place on Green Lane, Hounslow, east side, outside Nos. 103 to 126 Green Lane by 13.5 metres;
- reducing the length of the existing limited waiting parking place on Green Lane, Hounslow, north-east side, opposite No. 99 Green Lane by 15.5 metres.
