### **The London Borough of Hounslow (Revocations) Order 2026**

1. NOTICE IS HEREBY GIVEN that The London Borough of Hounslow on the 18 March 2026 has made the above-mentioned Order under sections 6 and 124 of and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Order will come into force on 10 April 2026.
2. The general effect of this Order will be to revoke the provisions of the Orders specified in the Schedule to this notice.
3. All made documents can be viewed online at [hounslow.gov.uk](http://hounslow.gov.uk) by typing in the term “traffic notices” in the search bar and at Hounslow Library, Hounslow House First Floor, 7 Bath Road, TW3 3EB or at The Reception of Hounslow House, Ground Floor, 7 Bath Road, TW3 3EB on Mondays and Thursdays between 9.30am and 8pm, Tuesdays, Wednesdays, Fridays and Saturdays between 9.30am and 5.30pm or on Sundays between 11.30am and 4.00pm.
4. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.

- 1 This Order shall come into operation on 10 April 2026 and may be cited as the London Borough of Hounslow (Revocations) Order 2026.
- 2 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Orders listed in the Schedule to this Order are hereby revoked.
