The Hounslow Local Plan will now be subject to an independent examination conducted by a planning inspector appointed by the Secretary of State. This is a continuous process running from the date of submission through to receipt of the appointed planning inspector's report. Once confirmed, details relating to the examination process will be advertised, made available online and sent to all respondents. To assist the planning inspector through the examination, an independent programme officer has been appointed. The programme officer works on behalf of the planning inspector to organise and manage the administrative and procedural matters of the examination and will be responsible for any communication with respondents during the examination.
