- Outline how the table and chairs will be managed. All tables and chairs will be positioned in accordance with the approved pavement licence plan and will not extend beyond the permitted area. Furniture will be placed to ensure a clear and safe pedestrian walkway is maintained at all times. Staff will regularly monitor the outdoor seating area to ensure tables and chairs remain orderly, do not obstruct access, and are used appropriately by customers. Any furniture that is moved will be repositioned promptly. The number of tables and chairs will be kept within the approved limit, and no additional furniture will be added without permission. All furniture will be removed or securely stored at the end of the permitted operating hours each day to prevent unauthorised use and to keep the area clear. The furniture used will be of a suitable quality and design to ensure stability and safety, and it will be maintained in good condition at all times.

- Outline how local nuisance will be managed. We will take all reasonable steps to ensure that the use of the pavement area does not cause nuisance to local residents or neighbouring businesses. Seating will be managed responsibly, with staff regularly monitoring the area to control noise levels and ensure customers behave considerately at all times. Operating hours for the outdoor area will be strictly adhered to, and furniture will be cleared promptly at the end of permitted times. Signage will be displayed asking customers to respect our neighbours, particularly when leaving the

premises. The area will be kept clean and tidy, with regular checks to remove litter and prevent waste build-up. Any spillages will be dealt with immediately to maintain safety and cleanliness. We will ensure that the pavement remains accessible at all times, maintaining clear pedestrian routes and accommodating those with mobility needs. In the event of any concerns or complaints, we will respond promptly and take appropriate action to resolve issues and prevent recurrence.
